WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, MARUTINANDAN SHIKSHA SAMITI, PLOT NO.22, STREET/ROAD – IN FRONT OF RUCHI SOYA PLANT, VILLAGE – GARDA ROAD GADARWARA, POST OFFICE/TEHSIL/TALUKA/TOWN/CITY – GADARWARA, DISTRICT – NARSINGHPUR, PIN CODE – 487551, MADHYA PRADESH (WRCAPP2871/222) had submitted on 30.05.2015 the application to the Western Regional Committee of the NCTE for grant of recognition to, MARUTINANDAN COLLEGE OF EDUCATION, KHASRA NO.147/7 & 147/8, PLOT NO.22, STREET NUMBER – GARDA ROAD, VILLAGE – OPP RUCHI SOYA PLANT, POST OFFICE/TEHSIL/TALUKA/TOWN/CITY – GADARWARA, DISTRICT – NARSINGHPUR, PIN CODE – 487551, MADHYA PRADESH for starting the D.El.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 29.10.2015, 17.12.2015, and 08.01.2016 requesting to give their recommendation/comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 19.01.2016 has given their recommendation

AND WHEREAS, WRC in its 241st meeting held on February 4-6, 2016 decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be. Accordingly, Show Cause Notice was issued to the institution on 15.02.2016 on the following grounds:-

Originally certified copy of land documents not submitted, only photocopy submitted.

Notarized copy of CLU/Diversion order not submitted, only photocopy submitted.

Blue print/Notarized copy of Building plan not submitted, only photocopy submitted.

Notarized Copy of Building Completion Certificate not submitted.

Notarized Copy of Non-Encumbrance Certificate not submitted. Affidavit of the Management regarding land details, not submitted.

FDRs not submitted as per NCTE Regulations, 2014.

No Objection Certificate from the affiliating body not submitted by the institution. Madhyamik Shiksha Mandal, Bhopal vide letter No.2908, Dated 16.07.2015 refused NOC

As per records, the institution is not a composite institution

AND WHEREAS, reply not submitted by the institution. The matter was placed before WRC in its 266th meeting held on January 10-12, 2016 and the Committee decided that "...Clarification letter/Show Cause Notice dt. 15/02/2016 was issued to the institution. Reply has not been received till date. Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of powers vested u/s 14(3)(b) of the NCTE Act, hereby refuses recognition to MARUTINANDAN COLLEGE OF EDUCATION, KHASRA NO.147/7 & 147/8, PLOT NO.22, STREET NUMBER - GARDA ROAD, VILLAGE - OPP RUCHI SOYA PLANT, POST OFFICE/TEHSIL/TALUKA/TOWN/CITY - GADARWARA, DISTRICT - NARSINGHPUR, PIN CODE -487551, MADHYA PRADESH for the D.El.Ed. Course.

Further, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi: 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
