WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SHREE DADAJI SHIVCHARAN YADAV SHIKSHA SAMITI, PLOT NO: 211, STREET NO: 03, VILLAGE: BHAMORI, POST OFFICE: SIHORA, TEHSIL: GADERWADA, CITY: GADERWADA, DISTRICT: NARSINGHPUR- 487551, MADHYA PRADESH had submitted the online application on 02.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to SHREE DADAJI SHIVCHARAN YADAV SHIKSHA SAMITI, PLOT/KHASARA NO- 211/3, PLOT NO 211, STREET NO: 03, VILLAGE: BHAMORI, POST OFFICE: SIHORA, TEHSIL: GADERWADA, CITY: GADERWADA, DISTRICT: NARSINGHPUR- 487551, MADHYA PRADESH for starting the B.ED. Course,

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 01.10.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show cause Notice to the rest..."

AND WHEREAS, Show Cause Notice was issued to the institution on the following points:-

- Name of the Institution/Society does not match with online application in NOC of University/affiliating body.
- Online Processing Fee payment slip not submitted.
- Address in Society Registraion Certificate & Bye-laws does not match with online application form.
- Intake not mentioned in the affidavit.
- Photocopy of Land documents submitted but certified copy not submitted.
- Photocopy of Building Plan submitted but Blue Print/Notarized copy not submitted.
- Notarized copy of Building Completion Certificate not submitted.
 - Photocopy of CLU submitted but notarized copy not submitted.
- Photocopy of NEC submitted approved by Rajasva Nirikshak, Diversion but notarized copy not submitted.
- In online application form, Existing/ Applied course not mentioned but as per our record, the institution has applied for D.El.Ed. Course (APP2750).
- Original FDRs not submitted, only coloured scanned copies of FDRs submitted.

AND WHEREAS, the Show Cause Notice was issued to the institution on 17.02.2016 and the reply of Show Cause Notice was received on 14.03.2016.

AND WHEREAS, the reply was placed before the WRC in its 248th Meeting held on February 4-6, 2016, the committee observed that:- "... The Committee also reviewed the status of the applications received for the academic session 2016-2017 and found that a number of applications where Show Cause Notices were issued and reply received are to be considered. In order to expedite the processing of such cases, the Committee decided that the RD, WRO should constitute VT in such cases where the institution has submitted reply/documents as per the requirements laid down in the NCTE Regulations, 2014 and in the Norms and Standards for that particular course. The case be put up before the WRC on receipt of the VTR."

AND WHEREAS, the Regional Director, WRO constituted the Visiting team.

AND WHEREAS, the inspection letter issued to the institution on 15.04.2016 and the inspection conducted of the institution on 21.04.2016.

AND WHEREAS, the reply was placed before the WRC in its 251st Meeting held on April 30-May 2, 2016, the committee observed that:- "...The VT visited the institution on 21/04/2016. However the inspection could not be done because the management was not prepared for the inspection. The management has submitted a letter to this effect.

The VT will be reconstituted when the management deposits a fee of Rs. 1.50 lakhs."

AND WHEREAS, the Clarification letter was issued to the institution on 06.05.2016 and the institution has not submitted the reply till date.

AND WHEREAS, the matter was placed before the WRC in its 266th Meeting held on January 10-12, 2017 and the Committee observed that "...Clarification letter/Show Cause Notice dt. 06/05/2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to SHREE DADAJI SHIVCHARAN YADAV SHIKSHA SAMITI, PLOT/KHASARA NO-211/3, PLOT NO 211, STREET NO: 03, VILLAGE: BHAMORI, POST OFFICE: SIHORA, TEHSIL: GADERWADA, CITY: GADERWADA, DISTRICT: NARSINGHPUR- 487551, MADHYA PRADESH for B.ED. Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order though online Mode using website www.ncte-india.org.
