REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993. KISHORI SHIKSHA SAMITI, SHOP NO. 29, WARD NO. 03, KUSHABHAU THAKRE COMPLEX, SAMRAT CHOUK, DIST. SIDHI MADHYA PRADESH had submitted the online application on 28.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to KISHORI SHIKSHA MAHAVIDHYALAYA, PLOT NO- 590/1, STREET- SATNARA ROAD, VILLAGE- KUKUDIJHAR, POST OFFICE- KUKUDIJHAR, TEHSIL- GOPAD BANAS, CITY- SIDHI, DISTRICT: SIDHI- 486661, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 05.10.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show cause Notice to the rest..."

AND WHEREAS, Show Cause Notice was issued to the institution on the following points:-

- In University/Affiliating body NOC, address not matched with Online Application Form.
- Address mentioned in Society Registration Certificate & Bye Laws does not match with Online Application Form.
- In Building plan, Built-up Area is less, as per NCTE norms.
- Notarized copy of Building Completion Certificate not submitted.
- Photocopy of "नोटिस प्रपत्र -बी" submitted but notarized copy of CLU not submitted.
- FDRs not submitted as per NCTE norms.

AND WHEREAS, the Show Cause Notice was issued to the institution on 12.02.2016 and the reply of Show Cause Notice was received on 24.05.2016.

AND WHEREAS, the reply was placed before WRC in its 257th Meeting held on August 02-04, 2016 and the Committee decided that "...Show Cause Notice dt. 12/02/2016 was issued, which returned undelivered. However, reply dt. 24/05/2016 has been received from Kishori Shiksha Mahavidyalaya informing that the address of the sponsoring Society was wrongly written by them earlier. Now they have informed the correct address of the Society.

The submitted documents were examined. It is seen that instead of a CLU, notice in Form-B has been submitted, according to which the land revenue has been revised. The notice is in the name of a private person and not the Kishori Shiksha Samiti. This is not acceptable.

Hence, Show Cause Notice be issued on this ground."

AND WHEREAS, the Show Cause Notice was issued to the institution on 10.08.2016 and the reply of Show Cause Notice was received on 08.11.2016.

AND WHEREAS, the reply was placed before the WRC in its 263rd Meeting held on November 25-27, 2016 the committee observed that: - "...Show Cause Notice was issued to the institution on 10/08/2016 and reply received on 08/11/2016.

An examination of the file shows that all the documents are in order except the NOC for which sanction from Higher Education Dept. has not been obtained. This is the condition which was put by the University.

Hence, Clarification be obtained from the institution on the above ground. The reply be submitted within 30 days."

AND WHEREAS, the matter was placed before the WRC in its 269th Meeting held on February 20-22, 2017 the committee observed that: - "Clarification letter/Show Cause Notice dt. 29/11/2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **KISHORI SHIKSHA MAHAVIDHYALAYA, PLOT NO- 590/1, STREET- SATNARA ROAD, VILLAGE- KUKUDIJHAR, POST OFFICE- KUKUDIJHAR, TEHSIL- GOPAD BANAS, CITY- SIDHI, DISTRICT: SIDHI- 486661, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website www.ncte-india.org.
