REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SHRI SANT KARTAR SINGH KALYAN SAMITI, PLOT NO- 522, STREET- JHANSI ROAD, VILLAGE- PURASANI, POST OFFICE- PURASANI, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR- 474001, MADHYA PRADESH had submitted the online application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to SHRI SAI NATH SHIKSHA MAHAVIDHYALAYA, PLOT NO- 522, VILLAGE- PURASANI, POST OFFICE- PURASANI, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR- 474001, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 18.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before WRC in its 235th Meeting held on November 23-24, 2015 and the Committee decided that "...The College applied online on 29.06.2015. However, the hard copy was received on 15.07.2015, which is more than the 15 days stipulated under the NCTE Regulations, 2014.

Hence, the application is summarily rejected and application fee paid be forfeited."

AND WHEREAS, the Rejection letter was issued to the institution on 01.12.2015 and Appeal order dated 02.06.2016 was received on 14.06.2016 remanding the case to WRC.

AND WHEREAS, the matter was placed before the WRC in its 261st Meeting held on October 26-28, 2016 the committee observed that: - "...This is a case of Appeal. The Appellate Authority vide letter dt. 02.06.2016 has remanded the case to WRC for further processing.

The RD WRO should get this case processed and should put them in the next meeting.

AND WHEREAS, the matter was placed before the WRC in its 263rd Meeting held on November 25-27, 2016 the committee observed that: - "...From the documents submitted by the institution it is seen that the Society has not submitted notarized copies of Building Plan, CLU, Building Completion Certificate and Non-Encumbrance Certificate.

Hence, Show Cause Notice be issued on the above grounds. The reply be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued to the institution on 30.11.2016 and the institution has not submitted the reply till date.

AND WHEREAS, the matter was placed before the WRC in its 269th Meeting held on February 20-22, 2017 the committee observed that: - "... Clarification letter/Show Cause Notice dt. 30/11/2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused."

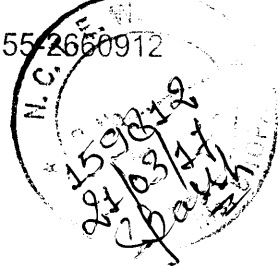
