REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SAVITRI DEVI GRAMIN AVAM SHIKSHA SAMITI, PLOT NO- 248, STREET- PATEL TIRAHA, NEW BUS STAND, POST OFFICE- REWA, TEHSIL-HUZUR, CITY- REWA, DISTRICT: REWA- 486001, MADHYA PRADESH had submitted the online application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to SURENDRA SINGH SMRITI SHIKSHA MAHAVIDHYALAYA, PLOT NO- 1250/2, 1251/2, STREET NO- PAHADIA, VILLAGE- PAHADIA, POST OFFICE- BAKCHHERA, TEHSIL- RAIPUR KARCHULIYAN, CITY- REWA, DISTRICT: REWA- 486001, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS. Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the negative recommendation.

AND WHEREAS, in 241st Meeting of the WRC held on February, 04-06. 2016, it was decided as under:-

“The WRC decided that the WRO should process these. constitute VTs where all documents are in order issue Show cause Notice to the rest...”

AND WHEREAS, Show Cause Notice was issued to the institution on 15.02.2016 on the following points:-

1. Copy of Change of land use (CLU) certificate issued by competent authority submitted but not notarized.
2. Notarized copy of Non-Encumbrance Certificate not submitted.
3. Building Completion Certificate signed by competent authority submitted but not notarized.
4. Institution does not fulfill the condition as per clause 2 (b) and 3 (a) of NCTE Regulations, 2014 according to which every teacher training institution has to be composite institution.
5. FDRs as per NCTE Regulations, 2014 not submitted.

AND WHEREAS, the reply was not submitted by the institution.

AND WHEREAS, the matter was placed before WRC in its 256th Meeting held on July 19-21, 2016 and the Committee decided that “... Show Cause Notice dt. 15/02/2016 was issued to the institution on the grounds of non submission of notarized copies of CLU, Non-Encumbrance Certificate, and Building Completion Certificate, and on being a standalone institution.

Since, no reply has been received,

hence, Recognition is refused.”

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to SURENDRA SINGH SMRITI SHIKSHA MAHAVIDHYALAYA, PLOT NO- 1250/2, 1251/2, STREET NO- PAHADIA, VILLAGE- PAHADIA, POST OFFICE- BAKCHHERA, TEHSIL- RAIPUR KARCHULIYAN, CITY- REWA, DISTRICT: REWA- 486001, MADHYA PRADESH for B.ED. Course.
