REFUSAL ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act **SHRI NARAYAN SINGH YADAV SHIKSHA PRASAR AVAM SAMAJ KALYAN SAMITI, PLOT NO.256/3, STREET/ROAD - GANWADI ROAD, VILLAGE - GANWADI, POST OFFICE/TEHSIL/TALUKA/TOWN/CITY - VIJAYPUR, DISTRICT - SHEOPUR, PIN CODE - 476337, MADHYA PRADESH (WRCAPP3348/222)** had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to **JAI SHRI RAM COLLEGE OF EDUCATION VIJAYPUR DISST. SHEOPUR, KHASRA NO.412/1, 412/2, 412/2/3, 412/3, 421, 458, 459, PLOT NO.256/3, STREET NO./VILLAGE - GANWADI, POST OFFICE/ TEHSIL/TALUKA/TOWN/CITY - VIJAYPUR, DISTRICT - SHEOPUR, PIN CODE - 476335, MADHYA PRADESH** for D.El.Ed. Course of 2 year duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 29.10.2015, 17.12.2015, and 08.01.2016 requesting to give their recommendation/comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 19.01.2016 has given their recommendation.

AND WHEREAS, WRC in its 241st meeting of WRC held on February 4-6, 2016 decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be. Accordingly, Show Cause Notice was issued on 15.02.2016

AND WHEREAS, reply received from the institution was placed in the 253rd WRC meeting held on May 24-26, 2016 and the Committee observed that "...Show Cause Notice was issued on 15/02/2016 and reply was received on 15/03/2016. An examination of the file shows that the institution has not replied to the Show Cause Notice point about the institution not being a composite one. This is a requirement under Clause 2(b) of the NCTE Regulations, 2014. No documents have been submitted in this regard. NOC from the affiliating body not submitted. Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of powers vested u/s 14(3)(b) of the NCTE Act, hereby refuses recognition to **JAI SHRI RAM COLLEGE OF EDUCATION VIJAYPUR DISST. SHEOPUR, KHASRA NO.412/1, 412/2, 412/2/3, 412/3, 421, 458, 459, PLOT NO.256/3, STREET NO./VILLAGE - GANWADI, POST OFFICE/ TEHSIL/TALUKA/TOWN/CITY - VIJAYPUR, DISTRICT - SHEOPUR, PIN CODE - 476335, MADHYA PRADESH** for the D.El.Ed. Course.


Further, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
