REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, Satguru Shiksha Prasara Evam Jankalyan Samiti, Plot no.: 00, Street/Road: Bedside Ashok Khare Satai Road, Vill.: Chhatarpur, P.O.: Chhatarpur, Teh./Tal.: Chhatarpur, Town/City: Chhatarpur, Dist.: Chhatarpur - 471001, Madhya Pradesh (WRCAPP3350) had submitted the application on 14.07.2015 to the Western Regional Committee of the NCTE for grant of permission to J J Institute of Teacher Education, Plot no.: 131, Street/Road: Panna Road, Vill.: Gathewra Chhatarpur P.O.: Chhatarpur, Teh./Tal.: Chhatarpur, Town/City: Chhatarpur, Dist.: Chhatarpur - 471001, Madhya Pradesh for B.A.B.Ed./B.Sc.B.Ed. 4 years integrated programme.

AND WHEREAS, as per decision taken by WRC in its 241th meeting held on February 4-6, 2016, Show Cause Notice was issued to the institution on 18.02.2016. on the following grounds:-

- 1 Notarized copy of Society registration certificate submitted. Memorandum, By-laws of the society /trust are not submitted.
- 2 Originally certified copy of registered land documents not submitted.
- 3 Originally notarized copy of Change of Land Use certificate issued by Sub-Divisional Officer, Chhatarpur submitted. Total Diverted land area is 0.310 hect. (3100 Sq. mtr) which is less as required for running D.Ed (222523) & proposed B.Sc.B.Ed./B.A.B.Ed.
- 4 Notarized copy of Building plan approved by competent authority not submitted.
- 5 Notarized copy of Building Completion certificate issued by Govt. Engineer (RES) not submitted.
- 6 Originally notarized copy of Non-Encumbrance certificate issued by Sub-Registrarr/ Revenue authority not submitted.
- 7 FDRs of Rs. Five lakhs as Endowment fund & Rs. Seven lakhs as Reserve fund not submitted.
- 8 The Institution is also directed to clarify for which course it has applied, i.e. for B.A. B.Ed or B.Sc. B.Ed.

AND WHEREAS, the reply of Show Cause Notice has not been received. The matter was placed before WRC in its 266th meeting held on January 10-12, 2017 and the Committee decided that "....Clarification letter/Show Cause Notice dt. 18/02/2016 was issued to the institution. Reply has not been received till date. Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses permission to J J Institute of Teacher Education, Plot no.: 131, Street/Road: Panna Road, Vill.: Gathewra Chhatarpur P.O.: Chhatarpur, Teh./Tal.: Chhatarpur, Town/City: Chhatarpur, Dist.: Chhatarpur - 471001, Madhya Pradesh for the B.A.B.Ed./B.Sc.B.Ed. 4 -Years integrated programme.
