REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **OM SAI RAM SAMAJ KALYAN SAMITI, PLOT NO- 539/1, 539/2, STREET- MAKRONIA, VILLAGE- MAKRONIA, POST OFFICE- MAKRONIA, TEHSIL- SAGAR, CITY- MAKRONIA, DISTRICT: SAGAR- 470004, MADHYA PRADESH** had submitted the application online on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to **PNS MEMORIAL COLLEGE, PLOT/KHASRA NO- 539/1, 539/2, VILLAGE- MAKRONIA, POST OFFICE- MAKRONIA, TEHSIL- SAGAR, CITY- MAKRONIA, DISTRICT: SAGAR- 470004, MADHYA PRADESH** for starting the **B.ED.** Course.

AND WHEREAS, the application of the institution was processed.

AND WHEREAS, SCN was issued to the institution on 17.02.2016 and the reply of SCN was received on 30.03.2016.

AND WHEREAS, the matter was placed before WRC in its 254th Meeting held on June 7-9, 2016 and the Committee decided that "...Show Cause Notice was issued on 17/02/2016 and the reply was received on 30/03/2016. From the documents submitted, it is seen that:-

- There are two land documents one for 0.40 hectares in the name of 'PNS College' and the other for 0.46 hectares in the name of 'PNS Memorial College'. The names do not match.
- CLU is only for 25,500 sq. ft. which is less than the requirement of 3000 sq. mtrs. for one unit of B.Ed. and one unit of D.El.Ed. course.
- Originally notarized copy of the building plan has not been submitted.
- In the Building Completion Certificate, the name of the College is mentioned 'PNS Memorial D.Ed. College' while in the NOC from the affiliating University, the College name is mentioned as 'PNS Shiksha Mahavidyalaya'. Also the Building Completion Certificate has been issued by the Sarpanch but not countersigned by the Engineer and it is not in the prescribed format. Khasra number, Plot area and built up area are also not mentioned in it.

Hence, Recognition for B.Ed. course is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **PNS MEMORIAL COLLEGE, PLOT/KHASRA NO- 539/1, 539/2, VILLAGE- MAKRONIA, POST OFFICE- MAKRONIA, TEHSIL- SAGAR, CITY- MAKRONIA, DISTRICT: SAGAR- 470004, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order though online Mode using website www.ncte-india.org.
