WHEREAS, in terms of Section 14 of the NCTE Act, 1993, MATHURA DEVI SHIKSHA PRASAR EVAM SAMAJ KALYAN SAMITI, PLOT NO- 224, STREET- NIMBAJI KI KHO, VILLAGE- JIWAJI GANJ, POST OFFICE- LASHKAR, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR- 474001, MADHYA PRADESH had submitted the application online on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to INDIRA INSTITUTE OF PROFESSIONAL STUDIES, PLOT/KHASRA NO- 1031/9, 1032/29, STREET- GHOTA ROAD, VILLAGE- VIJAYPUR, POST OFFICE- VIJAYPUR, TEHSIL- VIJAYPUR, CITY- VIJAYPUR, DISTRICT: SHEOPUR- 476337, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, the application of the institution was processed.

AND WHEREAS, Show Cause Notice was issued to the institution on 10.02.2016 and reply was received on 10.03.2016.

AND WHEREAS, the matter was placed before WRC in its 253<sup>rd</sup> meeting held on May 24-26, 2016 and the Committee decided that "...Show Cause Notice was issued on 10/02/2016 and reply was received on 10/03/2016. From the reply it is seen that the institution has still not submitted the following:-

- Originally certified copy of the land documents.
- Notarized copy of CLU and Non-Encumbrance Certificate.
- Building plan approved by competent authority.

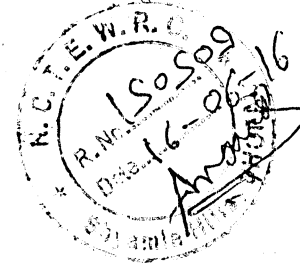
Hence, Recognition is refused."

Now therefore, the WRC, in exercise of powers vested under section 14(3) (b) of the NCTE Act, 1993, the recognition of, INDIRA INSTITUTE OF PROFESSIONAL STUDIES, PLOT NO- 1031/9, 1032/29, STREET- GHOTA ROAD, VILLAGE- VIJAYPUR, POST OFFICE- VIJAYPUR, TEHSIL- VIJAYPUR, CITY- VIJAYPUR, DISTRICT: SHEOPUR- 476337, MADHYA PRADESH for B.ED. Course is hereby refused.
