RÉFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, RAMRATAN GITA TRUST, PLOT NO. WARD NO.27, STREET/ROAD – PREM NAGAR, VILLAGE – NEAR SAI MANDIR, POST OFFICE/TEHSIL/TALUKA/ TOWN/CITY/DISTRICT – BALAGHAT, PIN CODE – 481001, MADHYA PRADESH (WRCAPP3471/222) had submitted on 30.06.2015 the application to the Western Regional Committee of the NCTE for grant of recognition to, SATGURU SHIKSHA MAHAVIDHYALAYA, KHASRA NO. – 88/1/1, 88/3, 88/3/1, PLOT NUMBER – 20, STREET ROAD – MAIN RAOD, VILLAGE/POST OFFICE – BARGHAT, TEHSIL/TALUKA – BALAGHAT, TOWN/CITY – BARGHAT, DISTRICT – SEONI, PIN CODE – 480667, MADHYA PRADES for starting the D.El.Ed. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 20.08.2015, 28.10.2015, and 09.12.2015 requesting to give their recommendation/comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 04.01.2016 has given their recommendation.

AND WHEREAS, WRC in its 241^{st} meeting held on February 4-6, 2016 decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be. Accordingly, Show Cause Notice was issued on 10.02.2016.

AND WHEREAS, the reply received from the institution was placed in the 253rd Meeting of WRC held on May 24-26, 2016 and the Committee decided that "...Show Cause Notice was issued on 10/02/2016 and reply was received on 21/03/2016. An examination of the file shows that the institution has submitted all the required documents. Regarding the Composite nature of the College, the Society has replied that it is running a B.Ed. College in the same plot by the name "Balaji B.Ed. College". The land documents are in different names. As per Clause 2(b) of the NCTE Regulations, 2014, both the courses should be run from the same institution/College. Hence, Clarification be obtained on the above ground." Accordingly, Clarification letter was issued on 14.06.2016.

AND WHEREAS, the reply received from the institution was placed in the 263rd Meeting of WRC held on November 25-27, 2016 and the Committee decided that "...Clarification letter was issued on 14/06/2016 and reply was received on 03/08/2016. The clarification related to the composite nature of the college. The Society vide its reply stated that their D.Ed. college is in the name of "Balaji B.Ed. College" and they have submitted an application to the Higher Dept. M.P. for change of name to "Satguru Shiksha Mahavidhyalaya". The institution has also stated that they are in the process of changing land and other documents. It also stated they have submitted a fee of Rs. 1.50 lakhs for change of the name of the B.Ed. college. However, a perusal of the file shows that there is no application for change of name nor the required fee. In the absence of the above documents, the application for the D.El.Ed. course cannot be considered. The Society is required to comply with this requirement within 30 days." Accordingly, letter was issued on 29.11.2016.

AND WHEREAS, reply not received from the institution. The matter was placed in the 269th WRC meeting held on February 20-22, 2017 and the Committee decided that "...Clarification letter/Show Cause Notice dt. 29/11/2016 was issued to the institution. Reply has not been received till date. Hence, Recognition is refused."
