**REFUSAL ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act, **RAMRATAN GITA TRUST, PLOT NUMBER - WARD NO.27, STREET/ROAD - PREM NAGAR, VILLAGE/TOWN/CITY/ POST OFFICE/TEHSIL/TALUKA/TOWN/CITY/DISTRICT - BALAGHAT, PIN CODE - 481001, MADHYA PRADESH (WRCAPP 3494/222)** had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to **KUSUM COLLEGE OF EDUCATION, PLOT/KHASRA NO.01, STREET NUMBER - MAIN ROAD, VILLAGE/POST OFFICE/TEHSIL/TALUKA/TOWN/CITY - TIMARNI, DISTRICT - HARDA, PIN CODE - 461228, MADHYA PRADESH** for D.El.Ed. Course of 2 year duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 20.08.2015, 28.10.2015, and 09.12.2015 requesting to give their recommendation/ comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 04.01.2016 has given their recommendation.

AND WHEREAS, the matter was placed in the 240<sup>th</sup> Meeting of WRC held on January 20-22, 2016 and the Committee decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued on 27.01.2016.

AND WHEREAS, reply not submitted by the institution. The matter was placed in the 253<sup>rd</sup> WRC meeting held on May 24-26, 2016 and the Committee observed that "...Show Cause Notice was issued to the institution on 27/01/2016 and reply has not been received. Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of powers vested u/s 14(3)(b) of the NCTE Act, hereby refuses recognition to **KUSUM COLLEGE OF EDUCATION, PLOT/KHASRA NO.01, STREET NUMBER - MAIN ROAD, VILLAGE/POST OFFICE/TEHSIL/TALUKA/TOWN/CITY - TIMARNI, DISTRICT - HARDA, PIN CODE - 461228, MADHYA PRADESH** for the D.El.Ed. Course.

Further, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
