**REFUSAL ORDER**

WHEREAS, in terms of section 14 of the NCTE Act, 1993 Late Shri Girija Shankar Education and Development Society, Plot No.: 81/5/2, Street/Road: Jhansi Road, Vill.: Mahua Bag, P.O.: Mohangarh, Tehsil/Taluka: Jatara, City: Tikamgarh, Dist.: Tikamgarh 472101, Madhya Pradesh had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition/permission to Shri Prakash Chandra Mahavidhalaya, Plot No.: 81/5/2, Vill.: Mahua Bag, P.O.: Mohangarh, Tehsil/Taluka: Jatara, City: Tikamgarh, Dist.: Tikamgarh 472101, Madhya Pradesh for conducting the B.A.B.Ed./B.Sc.B.Ed. 4 Years integrated programme

AND WHEREAS, the matter was placed before the WRC in its 249<sup>th</sup> meeting held on April 21-23, 2016 and the Committee decided that "...Show Cause Notice was issued to the institution on 16.02.2016. An examination of the reply shows that the institution has not as yet submitted notarized copy of Non-Encumbrance Certificate and Building Completion Certificate. Further, it is seen from the file that the Society has not submitted the originally certified copy of land documents. Hence, Clarification be obtained on the above grounds."


AND WHEREAS, the clarification letter was issued to the institution on 27.04.2016, and reply of the clarification letter was not submitted by the institution.

AND WHEREAS, the matter was placed before the WRC in its 257<sup>th</sup> meeting held on August 2-4, 2016 and the Committee decided that "...A letter dt. 27/04/2016 was issued to obtain Clarification. No response has been received. Hence, Recognition is refused. FDRs if any be returned.

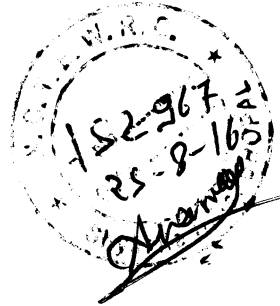
NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses recognition to Shri Prakash Chandra Mahavidhalaya, Plot No.: 81/5/2, Vill.: Mahua Bag, P.O.: Mohangarh, Tehsil/Taluka: Jatara, City: Tikamgarh, Dist.: Tikamgarh 472101, Madhya Pradesh for the B.A.B.Ed./B.Sc.B.Ed. 4 Years integrated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order online mode, using website www.ncte-india.org.
