**REFUSAL ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act **SHRI JEAN MATA SHIKSHA SAMITI, PLOT NO.71, 72, STREET/ROAD - GRAM SEHULA, VILLAGE - TH VIJAYPUR SHEOPUR, POST OFFICE/TEHSIL/TALUKA/ TOWN/CITY - VIJAYPUR, DISTRICT - SHEOPUR, PIN CODE - 476337, MADHYA PRADESH (WRCAPP3539/222)** had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to **RANI DURGAWATI COLLEGE, PLOT/KHASRA NO.71, 72, STREET NUMBER - VILL SEHUL, VILLAGE - SEHULA, POST OFFICE/TEHSIL/ TALUKA/TOWN/CITY - VIJAYPUR, DISTRICT - SHEOPUR, PIN CODE - 476337, MADHYA PRADESH** for D.El.Ed. Course of 2 year duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 30.10.2015, 17.12.2015 & 08.01.2016 requesting to give their recommendation/comments.

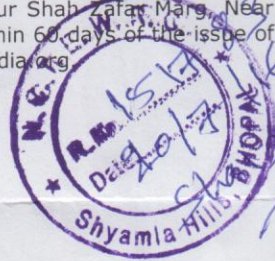
AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 04.01.2016 has given their recommendation.

AND WHEREAS, WRC in its 241<sup>st</sup> meeting of WRC held on February 4-6, 2016 decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be. Accordingly, Show Cause Notice was issued on 08.02.2016.

AND WHEREAS, reply received from the institution was placed in the 253<sup>rd</sup> WRC meeting held on May 24-26, 2016 and the Committee observed that "...Show Cause Notice was issued on 08/02/2016 and reply was received on 22/03/2016. An examination of the file shows that the institution has submitted all the required documents. The institution has replied that it is running B.A. and B.Com courses but no documentary proof regarding affiliation by the University has been submitted. NCC from the affiliating body has also not been submitted. Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of powers vested u/s 14(3)(b) of the NCTE Act, hereby refuses recognition to **RANI DURGAWATI COLLEGE, PLOT/KHASRA NO.71, 72, STREET NUMBER - VILL SEHUL, VILLAGE - SEHULA, POST OFFICE/TEHSIL/ TALUKA/TOWN/CITY - VIJAYPUR, DISTRICT - SHEOPUR, PIN CODE - 476337, MADHYA PRADESH** for the D.El.Ed. Course.

Further, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. 
