**REFUSAL ORDER**

WHEREAS, in terms of Section 14 (1) of the NCTE Act, 1993, **Bharat Uday Samajik Evam Sanskritik Sansthan Chhatarpur, Plot no. 157, Street/Road: Badi Kunje`rahti, Near Old Tehs, Vill.: Chhatarpur, P.O.: Chhatarpur, Teh./Tal.: Chhatarpur, Town/City: Chhatarpur, Dist.: Chhatarpur -471001, Madhya Pradesh (WRCAPP3558)** had submitted the application on **15.07.2015** to the Western Regional Committee of the NCTE for grant of recognition/permission to **Takshashila Mahavidyalaya, Plot no.: 2345/1/1, 2549/2, Street/Road: 00, Vill.: Panoutha, P.O.: Panoutha, Teh./Tal.: Ishanagar, Town/City: Chhatarpur, Dist.: Chhatarpur - 471001, Madhya Pradesh for B.Sc.B.Ed. 4 years integrated course.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 25.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in its 241<sup>st</sup> meeting held on February 4-6, 2016, the WRC decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be.

AND WHEREAS, application was scrutinized and following deficiencies/shortcomings were observed:-

- 1 Originally certified copy of registered land documents not submitted. Photocopy of Land Khasra No. 2345/1/1 of total land area is 1.489 hect. Submitted.
- 2 Originally Notarized copy of Change of Land Use certificate issued by Sub-Divisional Officer, not submitted. Photocopy of Land Khasra No. 2345/1/1 of total Diverted land area is 1.489 hect. Submitted.
- 3 Building Completion certificate issued by Govt. Engineer (RES) not submitted. it should be Notarized.
- 4 Notarized copy of Society registration certificate, Memorandum, By-laws of the society / trust are not submitted. Photocopy submitted.
- 5 Non-Encumbrance certificate issued by Sub-Registrar/ Revenue authority not submitted. it should be notarized.
- 6 FDRs of Rs. Five lakhs as Endowment fund & Rs. Seven lakhs as Reserve fund not submitted.
- 7 The Institution is also directed to clarify for which course it has applied, i.e. for B.A. B.Ed or B.Sc. B.Ed.
- 8 Institution does not fulfill the norms as per clause 2(b) and 3(a) of NCTE Regulations, 2014, according to which every teacher training institution has to be a composite institution.

AND, WHEREAS, the Show Cause Notice was issued on 24.02.2016 on the above grounds.

AND WHEREAS, the reply dt. 22.03.2016 of the Institution was placed before WRC in its 249<sup>th</sup> meeting held on April 21-23, 2016. The Committee decided that ".....*Show Cause Notice was issued to the institution on 24/02/2016 and the reply was received on 22/03/2016. A scrutiny of the reply shows that the institution has submitted all the required documents. It is also noticed that the institution has not submitted proof of running liberal courses in the current session i.e. 2015-2016.*

*VT be constituted and the VT should obtain the proof of running liberal courses from the management for the session 2015-2016."*

AND WHEREAS, The V.T. constituted on 26.04.2016. Dr. S.S. Gore, Barsi, Solapur (One VT member), vide letter dt. 02.06.2016 has inform that Takshila Mahavidyalaya, Panoutha, Ishanagar, Chhatarpur (code No. APP3558) has not given response to inspect their institution. Both the VT Members have visited the college dated 03/05/2016 at 11.00 am. The college was closed. Nobody was there to interact. They tried to communicate through Mobile. But the mobile number was not in service. So they could not inspect the college in the given duration.

AND WHEREAS, the matter was placed before WRC in its 265<sup>th</sup> meeting held from December 27-29, 2016. The Committee decided that "...The VT visited the institution on 03/05/2016 but the inspection could not be done as the institution was closed. The management has requested for another inspection. **The VT may be reconstituted as soon as the institution deposits the fee of Rs. 1.50 lakhs.**"

AND WHEREAS, the Clarification letter was issued on 03.01.2017 and the reply received from the institution on 01.02.2017.

AND, WHEREAS, the reply of the Institution was placed before WRC in its 269<sup>th</sup> meeting held on February 20-22, 2017. The Committee decided that "...Clarification letter was issued on 03/01/2017 regarding reconstitution of VT.

*The institution has not deposited the fee of Rs. 1.50 lakhs till date. Hence, Recognition is refused.*"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses recognition of **Takshashila Mahavidyalaya, Plot no.: 2345/1/1, 2549/2, Street/Road: 00, Vill.: Panoutha, P.O.: Panoutha, Teh./Tal.: Ishanagar, Town/City: Chhatarpur, Dist.: Chhatarpur -471001, Madhya Pradesh** for the **B.Sc.B.Ed. 4 -Years integrated programme.**

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website [www.ncte-india.org](http://www.ncte-india.org).
