REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, COM-FEEDER TAKNIKI PRASHIKSHAN SANSTHA, TALUKA/MANDAL - KASRAWAD, TOWN/CITY/DISTRICT - BARWANI, PIN CODE - 451551, MADHYA PRADESH (APP201660272/11476) had submitted on 30.06.2016 the application to the Western Regional Committee of the NCTE for grant of recognition to, MADHUBAN COLLEGE OF EDUCATION, VILLAGE - CHOTI KASRAWAD, STREET/ROAD - BARWANI BY PASS ROAD, TALUKA/MANDAL - BARWANI, TOWN/CITY - CHOTI KASRAWAD, DISTRICT - BARWANI, PIN CODE - 451551, MADHYA PRADESH for starting the D.El.Ed. Course.

AND WHEREAS, the matter was placed before WRC in its 268th meeting held on February 9-11, 2017 and the Committee decided that "...The institution applied on 30/06/2016 but hardcopy of the application is not received till date. Hence, Show Cause Notice be issued as to why the recognition should not be refused on the above ground. Reply should be submitted within 30 days." Accordingly, Show Cause Notice was issued on 17.03.2017.

AND WHEREAS, the reply not received from the institution was placed in the 279th Meeting of WRC held on August 10-11, 2017 and the Committee decided that "...Show Cause Notice was issued to the institution on 17.03.2017. the institute has not replied to till date. Hence, Recognition is refused. FDRs, if any, be returned."

NOW, THEREFORE, the WRC, in exercise of powers vested u/s 14 (3)(b) of the NCTE Act, hereby refuses recognition to MADHUBAN COLLEGE OF EDUCATION, VILLAGE - CHOTI KASRAWAD, STREET/ROAD - BARWANI BY PASS ROAD, TALUKA/MANDAL - BARWANI, TOWN/CITY - CHOTI KASRAWAD, DISTRICT - BARWANI, PIN CODE - 451551, MADHYA PRADESH for the D.El.Ed. Course.

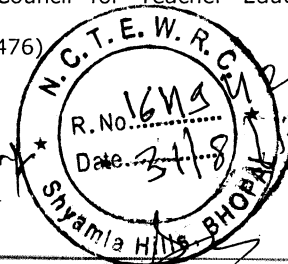
