REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, ADITYA EDUCATION SOCIETY, PLOT NO: 6-C, STREET: GLOBAL SQUARE, KAILASH VIHAR, VILLAGE: CITY CENTER, GWALIOR, POST OFFICE: R.K. PURI, TEHSIL: GWALIOR, CITY: GWALIOR- 474011, MADHYA PRADESH had submitted the online application on 20.05.2015 to the Western Regional Committee of the NCTE for grant of recognition ADITYA COLLEGE, PLOT/KHASRA NO: 172/7, STREET: GWALIOR BYPASS, VILLAGE: NAINAGIR, POST OFFICE: MORAR, TEHSIL: GWALIOR, CITY: GWALIOR, DISTRICT: GWALIOR- 474006, MADHYA PRADESH for starting the B.ED. course.

AND WHEREAS, the matter was placed before WRC in its 242<sup>nd</sup> Meeting held on February 11-13, 2016 and the Committee decided that "...The institution has applied for the B.Ed. course. It has also stated that it is running the B.Com, BBA, and other courses.

An examination of the file shows the following deficiencies:-

- Notarized copy of Society registration and By-laws not submitted;
- The photocopy of the land document is in the name of an individual which is not permitted as per NCTE regulations, 2014;
- Notarized copies of Building Plan, CLU and NEC and FDRs have not been submitted; and
- Building Completion Certificate not submitted.

Hence, Show Cause Notice be issued on the above grounds."


AND WHEREAS, the SCN letter issued to the institution on 16.02.2016 and the reply of SCN Letter was received on 01.03.2016.

AND WHEREAS, the matter was placed before WRC in its 248<sup>th</sup> Meeting held on April 11-12, 2016 and the Committee decided that "...Show Cause Notice was issued to the institution on ground that the photocopy of the land document submitted by the Society is in the name of an individual which is not permitted. In response to the Show Cause Notice, the Society has submitted that the registration of the land is in the name of the Society and it is not in the name of any individual. This explanation cannot be accepted as it is very clear from the records that the land is registered in the name of an individual. The Society has also not submitted the originally certified copy of the land documents.

Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to ADITYA COLLEGE, PLOT/KHASRA NO: 172/7, STREET: GWALIOR BYPASS, VILLAGE: NAINAGIR, POST OFFICE: MORAR, TEHSIL: GWALIOR, CITY: GWALIOR, DISTRICT: GWALIOR- 474006, MADHYA PRADESH for B.ED. Course.
