**REFUSAL ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, **DIAMOND SHIKSHA SHODH SAMITI, PLOT NO. 200, STREET/ROAD - DGI CAMPUS, VILLAGE/TOWN/CITY- MOHAN NAGAR, POST OFFICE/TEHSIL/TALUKA/CITY/ DISTRICT - RATLAM, PIN CODE - 457001, MADHYA PRADESH (WRCAPP3419/222)** had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to **RM INTERNATIONAL COLLEGE OF SCIENCE AND TECHNOLOGY, PLOT/KHASRA NO.179/8/1, STREET NUMBER. - MOHAN NAGAR, VILLAGE- JULWANIYA, POST OFFICE/TEHSIL/TALUKA/ CITY/DISTRICT- RATLAM, PIN CODE - 457001, MADHYA PRADESH** for **D.El.Ed** Course of 2 year duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 19.08.2015, 21.10.2015, and 09.12.2015 requesting to give their recommendation/ comments.

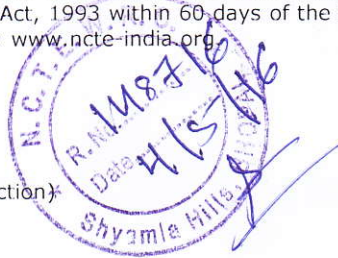
AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 04.01.2016 has given their recommendation.

AND WHEREAS, the matter was placed in 240<sup>TH</sup> WRC meeting held on January 20-22, 2016 and the Committee decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued on 27.01.2016.

AND WHEREAS, reply not received from the institution. The matter was placed in the 247<sup>th</sup> WRC meeting held on April 4-6, 2016 and the Committee observed that "...Show Cause Notice was issued to the institution on 27/01/2016 and the reply was received on 27/02/2016. The institution has not submitted any proof of affiliation to a University to run other liberal arts courses. **Hence, Recognition is refused. FDRs if any, be returned.**"

NOW, THEREFORE, the WRC, in exercise of powers vested u/s 14(3)(b) of the NCTE Act, hereby refuses recognition to **RM INTERNATIONAL COLLEGE OF SCIENCE AND TECHNOLOGY, PLOT/KHASRA NO.179/8/1, STREET NUMBER. - MOHAN NAGAR, VILLAGE- JULWANIYA, POST OFFICE/TEHSIL/TALUKA/ CITY/DISTRICT- RATLAM, PIN CODE - 457001, MADHYA PRADESH** for the **D.El.Ed.** Course.

Further, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
