In view of above, the application of your institution for B.Ed.M.Ed. Integrated course is hereby rejected.

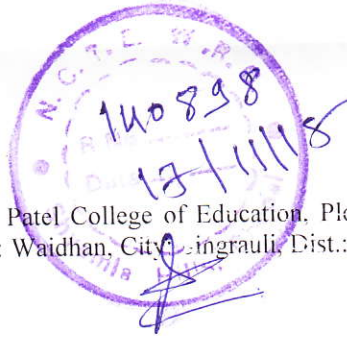
