Since the institution has not submitted the NOC, hence, the application be rejected."

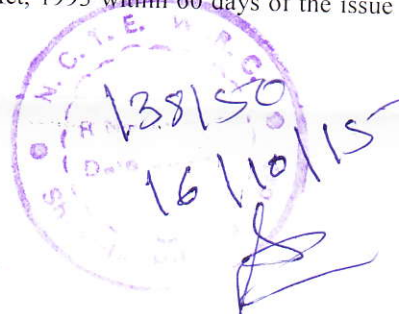
In view of above, the application of your institution for B.A.B.Ed./B.Sc.B.Ed. Integrated course is hereby rejected.
