Withdrawal Order U/S-17

Whereas, the recognition was granted to the institution namely, MEENA NIKETAN SHIKSHA MAHAVIDHYALAYA, OLD MAYO HOSPITAL BHAWAN, NEAR ARJUN BHAWAN, SHAHAJANABAD, BHOPAL MADHYA PRADESH for B.Ed. Course 100 Intake vide order dated 27-06-2005.

AND WHEREAS, letter was issued to the institution on 17-01-2015 (Affidavit Regarding Acceptance And Compliance of NCTE Regulations, 2014). The institution was not submitted reply (Affidavit).

AND WHEREAS, revised order was not issued to the institution.

AND WHEREAS, the matter was placed in 255<sup>th</sup> Meeting held on June 22-24, 2016 of WRC and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item.

AND WHEREAS, Show Cause Notice was issued to institution on 27.07.2016. The reply was not submitted by the institution till date.

AND WHEREAS, the matter was placed in 260<sup>th</sup> Meeting held on October 13-15, 2016 of WRC and the Committee decided that "...Show Cause Notice was issued 27/07/2016 for not submitting Affidavit to abide by the NCTE Regulations, 2014.

No reply has been received till date.

**Hence, Recognition is withdrawn under Section 17 of the NCTE Act, from the end of the academic session next following the date of withdrawal."**

Hence, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition of the institution is hereby withdrawal from the end of the academic session next following the date of order of Withdrawal.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
