**WITHDRAWAL ORDER**

WHEREAS, WRC, NCTE had granted recognition/permission to **SHREE INSTUTUTE OF TEACHERS EDUCATION, GANDHI NAGAR, ABBAS NAGAR NEAR R.G.P.V. NEW JAIL ROAD BHOPAL - 462036, MADHYA PRADESH** vide order no. APW04123/225040/WRC/5-6/APPEAL/2008/42267 dt. 10/09/2008 to start the M.Ed. course with an annual intake of 25 seats.

AND WHEREAS, the WRC vide order no. WRC/APW04123/225040/140<sup>th</sup>/2010/74424-74430 dt. 28.01.2011 enhanced the intake from 25 to 35 from the academic session 2010-2011.

AND WHEREAS, Letter dated 14.10.2013 was issued to the institution informing that the said institution does not fulfill the provisions as laid down in the Clause 8(5) of NCTE Regulations, 2009, and therefore, the name of the said institution no more figures in the list of recognized institutions of M.Ed. course.

AND WHEREAS, the matter was placed before WRC in its 212<sup>th</sup> WRC meeting held on November 28-29, 2014 and it was decided that "... Vide NCTE Letter No. 49-3/2011/NCTE/N&S/ dated 13.07.2012, attention was invited towards the requirement of Accreditation from NAAC to those teacher training institutions who have been granted additional intake in B.Ed., B.P.Ed., & M.Ed. & M.P.Ed. courses. This letter was uploaded on the web-site of NCTE, Bhopal on [www.nctewrc.co.in](http://www.nctewrc.co.in).

The institution **SHREE INSTITUTE OF TEACHER EDUCATION, BHOPAL** approached the Hon'ble High Court of Madhya Pradesh, Principal Seat at Jabalpur. Vide their order dated 08.07.2014, the Hon'ble High Court have quashed, 'the impugned action', while giving liberty to the NCTE to proceed afresh in accordance with the law. **Hence, Show Cause Notice be issued to the institution u/s 17(1) of NCTE Act, 1993.**"

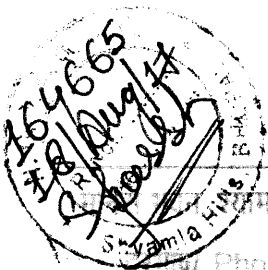
AND WHEREAS, Show Cause Notice issued on 22/12/2014. The reply to the Show Cause Notice was not submitted by the institution.

AND WHEREAS, NCTE, New Delhi vide notification dt. 28<sup>th</sup> November 2014, notified the new regulation, 2014.

AND WHEREAS, Institution vide letter dt. 04.02.2015 has submitted the affidavit regarding acceptance and compliance of NCTE Regulation, 2014. Accordingly, revised order issued to the institution on 19.05.2015 for M.Ed. course of two years duration with an annual intake of 50 students.

AND WHEREAS, as per para 2(i) of NCTE norms, 2014 of M.Ed. course, Institution eligible to apply for M.Ed. course is as:- Institutions offering teacher education programmes for a minimum period of five academic years, being affiliated to a university, and having applied for accreditation from NAAC or any other accrediting agency approved by NCTE.

AND WHEREAS, the B.Ed. course is withdrawn by WRC vide order dt. 10.08.2016, hence, the Institution does not fulfill the para 2 (i) of NCTE norms 2014 of M.Ed. course.

AND WHEREAS, the matter was placed before WRC in its 278<sup>th</sup> meeting held on July 25-26, 2017 and the Committee decided that "...*The recognition for the B.Ed. programme (APW00648/223190) was withdrawn vide order dt. 10.08.2016. Subsequently the institute was informed vide letter dt. 14.10.2013 that it no more figures in the list of recognized institution of the M.Ed. course. The institute needs to be issued a formal order for withdrawal of recognition.*"

NOW THEREFORE, recognition granted to **SHREE INSTUTUTE OF TEACHERS EDUCATION, GANDHI NAGAR, ABBAS NAGAR NEAR R.G.P.V. NEW JAIL ROAD BHOPAL - 462036, MADHYA PRADESH** for conducting M.Ed. course vide Recognition order dated 10/09/2008, 28/01/2011 & dt. 19.05.2015, is hereby withdrawn in terms of section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi – 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines or appeal are enclosed herewith.
