WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, GURU HARGOVIND SINGH SHIKSHA MAHAVIDHYALAYA, RUN BY KHALSA MINORITY TRUST, KHASRA NO - 1815/2/3, VILLAGE/TOWN/CITY - BAGOTA, STREET/ROAD/TALUKA/MANDAL - CHHATARPUR, DISTRICT - CHHATARPUR, PIN CODE - 471405, MADHYA PRADESH under section 14(3)(a) of NCTE Act, 1993 for conducting D.El.Ed. course of two years duration with an annual intake of 100 students vide order dated 04.05.2017.

AND WHEREAS, a complaint received from Shri Pawan Pratap Singh, Bureau Chief, Chhatarpur in Dainik Vijaymath against the College was forwarded by Madhyamik Shiksha Mandal, Bhopal. The matter was considered by the WRC in its 276th meeting held on May 30-31, 2017 and it was decided that "A complaint is received from Bureau Chief, Chhatarpur in Dainik Vijaymath. The WRC decided to do following:

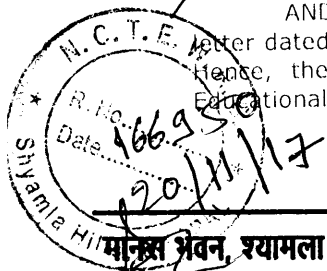
- Send the complaint together with the supporting documents to Guru Hargovind Singh Shiksha Mahavidhyalaya, Chhatarpur for para-wise reply.
- Send the complaint together with the supporting documents to the Collector/SDM, Chhatarpur for enquiry into the alleged fraud.
- Send the land documents to the Sub-Registrar Chhatarpur for verification and validity of the documents.
- Send the relevant documents and photographs to the Principal, Vijay Aadhunik Uchchitar Madhyamik Vidhyalaya Chhatarpur to reply to the allegation that the inspection for the proposed College took place in the premises of School.
- Send the relevant documents and photographs to the DEO, Chhatarpur for enquiry.

Till the enquiry is completed and reports submitted, no admissions shall be made in both B.Ed. and D.El.Ed. courses. The affiliating bodies be informed accordingly." Accordingly, letter was issued to the above authorities for verification and validation of documents. Further, letter was also issued to the Rajya Shiksha Kendra, Bhopal on 08.06.2017 requesting to ensure that no admissions shall be made in D.El.Ed. course till the enquiry in this case is completed and reports is received from different authorities.

AND WHEREAS, the matter was again considered by the WRC in its 278th Meeting held on July 25-26, 2017 and it was decided that "...The WRO vide letter dt. 08.06.2017 had asked the Rajya Shiksha Kendra not to allocate students for the D.El.Ed. course till the complaint is resolved. Subsequently, the Rajya Shiksha Kendra vide letter dt. 20.07.2017 had enclosed a letter of WRC no. 187493 dt. 11.07.2017 asking that the name of the College be included for counseling. This forged letter was received by Rajya Shiksha Kendra from the institution. Hence, Show Cause Notice be issued to the institution as to how this forged letter from WRC was obtained and submitted to Rajya Shiksha Kendra." Accordingly, Show Cause Notice was issued on 31.07.2017.

AND WHEREAS, WRC, NCTE vide letter No.WRC/NCTE/RD/2017/188260 dated 9th August, 2017 forwarded copies of minority certificates submitted by the institutions, which have been granted recognition for D.El.Ed. course, to National Commission for Minority Educational Institutions, New Delhi for confirmation, that these certificates have been issued by their office as per the Number and date mentioned in the minority certificates.

AND WHEREAS, the National Commission for Minority Educational Institutions, New Delhi vide letter dated 19.09.2017 has confirmed the minority status to only seven of these sixteen institutions. Hence, the minority certificate has not been issued by the National Commission for Minority Educational Institutions, New Delhi to the institution.

AND WHEREAS, the reply submitted by the institution to Show Cause Notice and the letter dated 19.09.2017 received from the National Commission for Minority Educational Institutions, New Delhi were placed before WRC in its 282nd meeting held on October 24-26, 2017 and the Committee decided that "...In response to complaint received on 24.05.2017, the case was referred to the Collector/SDM, Chhattarpur. Since there were two conflicting reports from the same SDM, both the reports were referred to the Collector/SDM. The SDM, Chhattarpur had confirmed that the first report dated 13.06.2017 should be considered as the valid report. **Since, this report is negative with regard to documents, infrastructure etc., Recognition is withdrawn with immediate effect.**"

NOW THEREFORE, the recognition granted to **GURU HARGOVIND SINGH SHIKSHA MAHAVIDHYALAYA, RUN BY KHALSA MINORITY TRUST, KHASRA NO - 1815/2/3, VILLAGE/TOWN/CITY - BAGOTA, STREET/ROAD/TALUKA/MANDAL - CHHATARPUR, DISTRICT - CHHATARPUR, PIN CODE - 471405, MADHYA PRADESH** for conducting D.E. Ed course vide order dated 04.05.2017 is hereby withdrawn under section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
