

**AFFIDAVIT ON 100/- NON-JUDICIAL STAMP PAPER, TO BE

1- That, I am president/secretary of (Name and address of the society/trust) sponsoring (Name and address of the proposed institution) for conducting the B.Ed./D.El.Ed./M.Ed. etc. course.
