ORDER

WHEREAS, WRC, NCTE had granted recognition/permission to Deorao Patil D.Ed. College, Loni Tq. Arni Dist. Yavatmal, Maharashtra (APW02337/122224) vide order No.- WRC/NCTE/2006-2007/C-15261-15262 dt- 04.05.2007 for conducting D.Ed. course with an annual intake of 50 students.

AND, WHEREAS, the institution vide letter dated 04.10.2016 requested to close the D.Ed course.

AND, WHEREAS, the matter was placed before the WRC in its 271st WRC meeting held on March 23-25, 2017, The Committee decided as under:-

Hence, Recognition is refused u/s 14 (3) (b) of NCTE Act, 1993. FDRs be returned, if any."
