REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, **GURU RAMDAS COLLEGE OF EDUCATION, PLOT/KHASRA NO. 25/14K, JABALPUR NAKA, NEAR GOVT. POLYTECHNIC COLLEGE, DAMOH, MADHYA PRADESH** had submitted the application on 29/04/2008 to the Western Regional Committee of the NCTE for grant of permission for starting the **M.Ed.** Course.

AND WHEREAS, the application of the institution was processed and deficiencies communicated to the institution vide letter dated 22/05/2008.

AND WHEREAS, the reply submitted by the institution was placed before WRC in its 121st meeting held on July 8-9, 2009 and the Committee decided to reject the application. Accordingly, rejection order was issued on 24/07/2009 on the following ground:-

- *Deficiency not removed within the stipulated time.*

AND WHEREAS, the institution preferred an appeal against the rejection order and the Council vide order dt. 12/02/2010 remand back the case to WRC.

AND WHEREAS, the matter was placed before WRC in its 132nd meeting held on March 19-20, 2010 and the Committee decided to reject the application. Accordingly, rejection order was issued on 17/04/2010 on the following ground:-

- *Certified copy of land document not submitted.*
- *CLU not submitted.*
- *FDR Rs. Five lacs and three lacs not submitted.*
- *Built up area for B.Ed. not earmarked.*

AND WHEREAS, the institution again preferred an appeal against the rejection order and the Council passed an order dt. 17/09/2010.

AND WHEREAS, the matter was placed before WRC in its 142nd meeting held on November 22-24, 2010 and the Committee decided that VT be constituted.

AND WHEREAS, the inspection of the institution was conducted on 17/02/2011. The matter was placed before WRC in its 148th meeting held on April 10-12, 2011 and the Committee decided that Letter of Intent be issued. Accordingly, Letter of Intent u/c 7(9) of NCTE Regulations 2009 was issued to the institution on 25/04/2011.

AND WHEREAS, the reply submitted by the institution was placed before WRC in its 152nd meeting held on July 10-12, 2011 and the Committee decided that Show Cause Notice be issued. Accordingly, Show Cause Notice was issued to the institution on 19/05/2012 on the following grounds:-


- *The staff list is not approved by the Registrar of the University.*
- *Certificate of NAAC Accreditation not submitted.*

AND WHEREAS, the reply dated 28/05/2012 submitted by the institution was placed before WRC in its 166th meeting held on July 09-10, 2012 and the Committee decided to refuse the recognition on account of the following point:-

- *The institution has not been able to submit staff list approved by affiliating body and NAAC Accreditation.*

AND WHEREAS, the Refusal Order was issued on 30.07.2012.

AND WHEREAS, the institution preferred an appeal dt. 29.08.2012 and the Council vide order dt. 06.03.2013 confirmed the refusal order of WRC.

AND WHEREAS, the institution thereafter filed W.P. No. 6445/2013 in the Hon'ble High Court of Madhya Pradesh, Principal Seat at Jabalpur. The Hon'ble High Court in their order dt. 27.10.2014 have directed the petitioner to submit a fresh application for the ensuing academic year for recognition.

AND WHEREAS, the matter was placed before WRC in its 212th meeting held on November 28-29, 2014 and the Committee decided that "...*Shri Gurunanak Education Society had applied for Recognition of a M.Ed. course which was refused on the grounds of non-submission of staff-list and NAAC Accreditation. The Society approached the Hon'ble High Court of Madhya Pradesh. The Hon'ble High Court in their order dated 27.10.2014 have directed the petitioner to submit a fresh application for the ensuing academic year for Recognition. Hence, the case be put up as and when fresh application, as per the new Regulations, is submitted by the Gurunanak Education Society, Damoh.*"

AND, WHEREAS, the Letter was issued on 23.12.2014 to make a fresh application as per Statuary rules and regulation.

AND WHEREAS, the institution filed W.P. No. 11483/2015 in the Hon'ble High Court of Madhya Pradesh, Principal Seat at Jabalpur and the Hon'ble High Court had passed an order dt. 23.07.2015.

AND WHEREAS, the matter was placed before WRC in its 232nd meeting held on September 16-17, 2015 and the Committee decided that "...*Keeping in view the direction of the Hon'ble High Court dated 23.07.2015 in writ petition No. 11483/2015, the case be processed as per Regulations, 2014 for recognition and put up before the Committee.*"

AND WHEREAS, the matter was again placed before WRC in its 234th meeting held on November 03-05, 2015 and the Committee decided to issue Letter of intent under Clause 7(13) of NCTE Regulations, 2014. **Accordingly, Letter of Intent was issued on 19.11.2015.**

AND WHEREAS, the reply of Letter of intent not submitted by institution. The institution vide letter dt. 15.03.2016, 12.04.2016 & 21.10.2016 has requested not to process the case further of M.Ed. course.

AND WHEREAS, the matter was placed before WRC in its 282nd meeting held on October 24-26, 2017. The Committee decided that "...*LOI was issued to the institution on 19.11.2015, to which no reply was received. Now, the institution vide letter dated 21.10.2016 has requested not to process the case further. Hence, Recognition is refused. FDRs be returned, if any.*"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses permission to **GURU RAMDAS COLLEGE OF EDUCATION, PLOT / KHASRA NO. 25/14K, JABALPUR NAKA, NEAR GOVT. POLYTECHNIC COLLEGE, DAMOH, MADHYA PRADESH** for the **M.Ed. 2 - Years** programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
