## Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Kheralu Taluka, Uttar Vibhag Kelvani Mandal, Kheralu, Mehsana, Gujarat - 384325 had applied on 13.07.2016 in the Western Regional Committee, NCTE, Bhopal under section 14 of the NCTE Act, 1993, for grant of recognition for conducting B.Ed.M.Ed.(Integrated) Course.

And whereas, after scrutiny of the application file was placed before WRC in its 266th held on 10<sup>th</sup>-12<sup>nd</sup> January, 2016, committee decided to issue Show Cause Notice dt. 17.01.2017.

And whereas, reply of Show Cause Notice was received in the office on 30.01.2016 and 06.02.2017 matter was placed before the WRC in its 269th meeting held on 21<sup>st</sup> - 23<sup>rd</sup> February, 2017 and the Committee decided to issue refusal order to the institution on following points :-

"The case file was seen. The institution applied for the B.Ed.M.Ed. integrated course for which a Show Cause Notice was issued to the effect that the institution was not eligible.

The management vide letter dt. 20/02/2017 has stated that they do not want the B.Ed.M.Ed. integrated course. they have requested to treat their application as additional intake for the B.Ed. course.

Once the application is made online, it cannot be changed. Further, the institution is already running the B.Ed. course with dt. 2 units. As per NCTE Hqrs. letter dt. 08.12.2016 which has clarified that, "...the institutions may apply for increase in intake in the same course already recognized provided it does not exceed maximum of two permissible units in case of DPSE, D.El.Ed. and B.Ed. Any application for increase in intake beyond two permissible units in these three courses is not permissible under the regulation...the institution cannot have more than 2 units."

**Hence, Recognition is refused.**

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to N.S. Desai College of Education, Kheralu, Ambaji Highway Sidhpur Road, Kheralu Taluka, Uttar Vibhag Kelvani Mandal, Kheralu, Mehsana, Gujarat - 384325.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 [www.ncte-india.org](http://www.ncte-india.org) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
