Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Mohd. Isak Patel D.Ed. College, Plot No236, Jawala Bazar, Village & Po. Jawala Bazar, Teshil-Aundha Nagnath, Dist.-Hingoli 431705, Maharashtra had submitted the application on 27.09.2011 to the Western Regional Committee of the NCTE for grant of recognition to Mohd. Isak Patel D.Ed. College, Plot No. 236, Jawala Bazar, Village & PO.-Jawala Bazar, Tehsil-Aundha Nagnath, Dist.-Hingoli 431705 for starting the D.El.Ed. Course.

And, whereas, the proposal was examined and the deficiency letter was issued to the institution on 28.12.2011.

And, whereas, the reply submitted by the institution, was received on 28.12.2012.

And, whereas, the matter was placed before WRC in its 161st meeting held on 02-04, April, 2012, and the Committee decided to issue show cause notice to the institution Accordingly, show cause notice was issued on 29.05.2012, and the institution submitted reply on 03.07.2012.

And, whereas, the matter was placed before WRC in its 167th meeting held on 24-26, July, 2012 and the Committee decided to seek clarification from the institution. Accordingly, clarification was sought on 21.08.2012, and institution submitted reply on 22.08.2012.

And, whereas, the matter was placed before WRC in its 172nd meeting held on 13-15, October, 2012 and the Committee decided to refuse recognition under section 14 (3) (b) of NCTE Act 1993.

And, whereas, Refusal order was issued to the institution on 04.12.2012

And, whereas, the institution preferred an appeal before the Council (NCTE) under section 18 of NCTE Act, 1993. The Appellate Authority vide order dated 01.04.2013 accepted the appeal and remanded the matter to the WRC for further consideration as per Regulations.

And, whereas, the matter was placed before was placed before WRC in its 184th meeting held on May 27-29, 2013. The committee decided that "..... The WRO has not examined the case file, which makes the position of the letters mentioned in the appeal order clear, nor provided any information of the actual number of course being conducted by this institution."

And, whereas, the matter was placed before WRC in its 185th Meeting held on June 13-15, 2013 and the Committee decided that VT be constituted. Accordingly, Inspection was conducted on 08.02.2016 & 09.02.2016.

And, whereas, the matter was placed before WRC in its 242nd meeting held on February 11-13, 2016. The committee decided to issue letter of intent to the institution. Accordingly, letter of intent was issued on 24.02.2016, and the institution did not submit reply of letter of intent.

And, whereas, the matter was placed before WRC in its 255th meeting held on 22-24, June, 2016, and the Committee decided to issue show cause notice to the institution. Accordingly, show cause notice was issued on 13.07.2016, and the institution did not submit reply of show cause notice.

And, whereas, the matter was placed before WRC in its 266th meeting held on 10-12, January, 2017, and the Committee decided as follows:-

"The case file was seen. Clarification letter/Show Cause Notice dt. 13/07/2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused.

Now, therefore, in exercise of the powers vested under section 15(3)(b) of NCTE Act, 1993, the Western Regional Committee hereby refuses permission Mohd. Isak Patel D.Ed. College, Plot No. 236, Jawala Bazar, Village & PO.-Jawala Bazar, Tehsil-Aundha Nagnath, Dist.-Hingoli 431705 for conducting the D.El.Ed. Programme.

Further, if the institution is not satisfied by the order, they may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
