REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **SMT. SONA DEVI PATEL MAHILA MANDAL, PLOT NO- 62/2, STREET: NH-26, VILLAGE- RAJMARG (PALOHA), POST OFFICE: SUATALA, TEHSIL- KARELI, CITY- PALOHA CHHOTA, DISTRICT: NARSINGHPUR- 487330, MADHYA PRADESH** had submitted the online application on **30.06.2015** to the Western Regional Committee of the NCTE for grant of recognition to **SVN COLLEGE, PLOT NO: N.H. 26, KHASRA NO. 62/2, STREET- KARELI, VILLAGE- RAJMARG (PALOHA), POST OFFICE- SUATALA, TEHSIL- KARELI, CITY- PALOHA CHHOTA, DISTRICT- NARSINGHPUR: 487330, MADHYA PRADESH** for starting the **B.ED. Course**.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on **27.10.2015** requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated **09.10.2015** has given the recommendation.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-
"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show cause Notice to the rest..."

AND WHEREAS, Show Cause Notice was issued to the institution on the following points:-

1. Certified copy of registered land documents issued by the competent authority a required under provision of section 8(4)(i) of NCTE, Regulations, 2014 not submitted.
2. Blue Print/Notarized copy of Building Plan issued by competent authority not submitted. (submitted photocopy)
3. Notarized Copy of Building Completion Certificate issued by competent authority not submitted.
4. A notarized copy of Change of land use (CLU) certificate not Submitted. (submitted photocopy)
5. FDRs as per NCTE Regulations, 2014 not submitted.
6. In online Application Form, Existing/applied Course not mentioned but as per our record, the institution has applied D.El.Ed. Course APP3264.
7. In Online Application Form & as per office record, institution has not applied for/nor conducting any other Teacher Education Course. Hence, institution is not fulfilling Clause 2 (b) of NCTE Regulations, 2014.

AND WHEREAS, the Show Cause Notice was issued to the institution on **18.02.2016** and the reply was received on **15.03.2016 & 20.04.2016**.

AND WHEREAS, the reply was placed before the WRC in its 248th Meeting held on April 11-12, 2016, the committee observed that:- "...The Committee also reviewed the status of the applications received for the academic session 2016-2017 and found that a number of applications where Show Cause Notices were issued and reply received are to be considered. In order to expedite the processing of such cases, the Committee decided that the RD, WRO should constitute VT in such cases where the institution has submitted reply/documents as per the requirements laid down in the NCTE Regulations, 2014 and in the Norms and Standards for that particular course. The case be put up before the WRC on receipt of the VTR."

AND WHEREAS, the RD WRO constituted the Visiting Team.

AND WHEREAS, the inspection letter issued to the institution on **23.04.2016** and the inspection conducted of the institution on **03.05.2016 & 04.05.2016**.

AND WHEREAS, the VTR was placed before the WRC in its 260th Meeting held on October 13-15, 2016 and the Committee observed that "...The VT visited the institution on 03/05/2016 and 04/05/2016. The VTR was perused. The VT has remarked that the building is still under construction. However, Building Completion Certificate has been submitted for ground floor and first floor. This is not acceptable.

Lab facilities are inadequate and non-functional. Library resources are yet to be procured.

Hence, Show Cause Notice be issued on the above grounds.

Further, the CD could not be viewed as the CD did not show anything. The institution is advised to send another copy of the CD with all the details."

AND WHEREAS, the Show Cause Notice was issued to the institution on **19.10.2016** and the reply was received on **04.11.2016**.

AND WHEREAS, the reply was placed before the WRC in its 264th Meeting held on December 14-15, 2016 and the Committee observed that "...Show Cause Notice was issued to the institution on the ground that Building is under construction but BCC has been submitted.

There were other deficiencies in the Lab. and Library. The institute vide reply 04.11.2016 has submitted a BCC for 3358 sq ft. A VT is required to verify the extent of civil construction.

The institute is required to submit a fee of Rs. 1.50 lakhs for both the cases to reconstitute the VT."

AND WHEREAS, the Clarification letter was issued to the institution on **19.12.2016** and the reply was received on **04.01.2017**.

AND WHEREAS, an inspection letter was issued to the institution through online on **12.01.2017** and the inspection conducted of the institution on **08.02.2017 & 09.02.2017**.

AND WHEREAS, the VTR was placed before the WRC in its 269th Meeting held on February 20-22, 2017 and the Committee observed that "...The VT visited the institution on 08/02/2017 and 09/02/2017. The VTR was perused but the CD could not be viewed because a proper CD was not sent.

The observation of the VT is "Though the Society has obtained BCC, the work has yet to be done. The ground floor has been completed. The first floor needs to be complete. The Society has given an understanding to complete the work by the commencement of the session 2017-2018".

The same observations were given by the earlier VT which visited the institution on 3rd & 4th of May, 2016.

Hence, Show Cause Notice be issued as to why the recognition should not be refused on the above grounds.

Reply should be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued to the institution on **28.02.2017** and the institution has not submitted the reply till date.

AND WHEREAS, the matter was placed before the WRC in its 279th Meeting held on August 11-12, 2016 and the Committee observed that "...Show cause notice was issued to institution on 28.02.2017. The institute has not replied till date.

Hence, Recognition is refused.
FDRs, if any, be returned."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **SVN COLLEGE, PLOT NO: N.H. 26, KHASRA NO. 62/2, STREET- KARELI, VILLAGE- RAJMARG (PALOHA), POST OFFICE- SUATALA, TEHSIL- KARELI, CITY- PALOHA CHHOTA, DISTRICT- NARSINGHPUR: 487330, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Ba.hadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website www.ncte-india.org.
