REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, ABHISHEK SHIKSHA EVAM SAMAJ KALYAN SAMITI, PLOT NO- 1441/60, STREET NO- 60, VILLAGE- PIPROLI, POST OFFICE- LASHKAR, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR- 474001, MADHYA PRADESH had submitted the online application on 28.05.2015 to the Western Regional Committee of the NCTE for grant of recognition to ABHISHEK INSTITUTE OF PROFESSIONAL STUDIES, PLOT NO- 15,16, 39/66, STREET NO- 60, VILLAGE- PIPROLI, POST OFFICE- LASHKAR, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR- 474001, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has recommended the case.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show cause Notice to the rest..."

AND WHEREAS, Show Cause Notice was issued to the institution on the following points:-

1. Certified copy of registered land documents issued by the competent authority as required under provision of section 8(4) (i) of NCTE, Regulations, 2014 not submitted.
2. Blue Print / Notarized copy of Building Plan issued by competent authority not submitted.
3. Built-up area required 3500 SQMT whereas as the institution has built up area measuring 3039.03 SQMT.
4. Notarized Copy of Building Completion Certificate issued by competent authority not submitted. (submitted photocopy)
5. A notarized copy of Change of land use (CLU) certificate not submitted. (submitted photocopy)
6. Notarized Copy of Non-Encumbrance Certificate issued by competent authority not submitted. (submitted photocopy)
7. FDRs as per NCTE Regulations, 2014 not submitted.

AND WHEREAS, the Show Cause Notice was issued to the institution on 17.02.2016 and the reply was received on 15.03.2016 & 18.03.2016.

AND WHEREAS, the reply was placed before the WRC in its 255th Meeting held on June 22-24, 2016, the committee observed that: "...The applicant Society has applied for B.Ed. Co.Ed. course. The institution - Abhishek Institute of Professional Studies is already recognized for D.El.Ed. course. The documents submitted for the B.Ed. course are in order.

Hence, VT be constituted."

AND WHEREAS, the inspection letter issued to the institution on 01.07.2016.

AND WHEREAS, the institution has informed on 01.07.2016 & 04.07.2016 and VT member (Dr. Pratiksha Sharma) has informed on 12.07.2016 that it is not interested for inspection and seeking for refund the inspection fee.

AND WHEREAS, the matter was placed before the WRC in its 265th Meeting held on December 27-29, 2016 and the Committee observed that "...The VT was constituted but the institution vide letter dt. 30/06/2016 has written that they are no more interested in the inspection.

For withdrawing an application, it needs to send a resolution from the management. Further, there is neither any provision for refunding the application fee nor transferring it for any future application."

AND WHEREAS, an information letter was issued to the institution on 03.01.2017.

AND WHEREAS, the matter was placed before the WRC in its 279th Meeting held on August 10-11, 2017 and the Committee observed that "...The WRO vide letter dt. 03.01.2017 informed that the institute needs to submit resolution for not running B.Ed. course. The institute has not replied to till date.

Hence, Recognition is refused.

FDRs, if any, be returned."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **ABHISHEK INSTITUTE OF PROFESSIONAL STUDIES, PLOT NO- 15,16, 39/66, STREET NO- 60, VILLAGE- PIPROLI, POST OFFICE- LASHKAR, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR- 474001, MADHYA PRADESH** for B.Ed. Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Ba.hadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website www.ncte-india.org.
