REFUSAL ORDER

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, MAHARAJA COLLEGE, PLOT NUMBER: 22, 26/1, STREET NUMBER: 36, VILLEGE: CHANDESRI, POST OFFICE: MOTILAL NEHRU NAGAR, TEHSIL/TALUKA: CHANDESRI, TOWN/CITY: UJJAIN, DISTRICT: UJJAIN 456010, MADHYA PRADESH had submitted the application on 01/10/2011 to the Western Regional Committee of the NCTE for grant of permission for starting the M.Ed. (Addl. Intake) Course.

And whereas, the application of the institution was processed and deficiencies communicated to the institution vide letter dated 29/02/2012.

And whereas, the reply dated 20/04/2012 submitted by the institution was placed before WRC in its 163rd meeting held on May 22-24, 2012 and the Committee decided to issue Show Cause Notice. Accordingly, Show Cause Notice was issued to the institution on 23/06/2012.

And whereas, the reply submitted by institution on 24/07/2012 was placed before WRC in its 169th meeting held on August 22-24, 2012 and the Committee decided to refuse permission on account of the following point:-

"...It is seen from the documents that the college does not have NAAC Accreditation required under Clause 8(4) of NCTE Regulation 2009. Hence Recognition is Refused under Section 15(3)(b) of NCTE Act."

Accordingly, Refusal order was issued to the institution on 17/09/2012.

And whereas, institution has preferred an appeal dated 10/10/2012 against the Refusal Order dated 17/09/2012 and the Council rejected the appeal and confirmed the order of WRC.

And whereas, the institution thereafter filed W.P. No.10014/2013 in the Hon'ble High Court of Madhya Pradesh, Principal seat at Jabalpur bench at Indore. The Hon'ble High Court has passed an order dated 04/12/2013.

And whereas, the court order dt. 04/12/2013 was placed before WRC in its 229th meeting held on July 21-22, 2015 and the Committee decided to issue Show Cause Notice. Accordingly, Show Cause Notice was issued to the institution on 04/08/2015.

And whereas, the reply submitted by institution on 01/09/2015 was placed before WRC in its 234th meeting held on November 3-5, 2015 and the Committee decided to refuse permission on account of the following point:-

"Show Cause Notice was issued on 04.08.2015 regarding insufficiency of built up area. The institute vide their reply dated 01.09.2015 has stated that they have more than 5000 sq.mts. of built up area without enclosing any proofs by supporting documents. Hence, Recognition for additional unit of M.Ed. course is refused." Accordingly Refusal order was issued to the institution on 17.11.2015.

And whereas, the institution has filed an appeal dated 14.01.2016 against the refusal order dated 17.11.2015, and the council vide appeal order dated 26.09.2016 has remanded the case to the WRC for further processing of the case.

AND WHEREAS, the appeal order dated **26.09.2016** was placed before the WRC in its **266th meeting held on January 10-12, 2016** and the Committee decided that "...*This is a case of Appeal. The Appellate authority vide order dt. 26/09/2016 has remanded the case to WRC for further processing.*"

Since the institution has fulfilled all the requirements, VT be constituted."

And whereas, the VT letter was issued on **20.01.2017**. Institution vide letter dated **02.02.2017** has requested to postpone the inspection of the institution for six (6) months.

AND WHEREAS, the matter was placed before WRC in its **271st meeting held on March 23-25, 2017**. The Committee decided that "...*This is a case of appeal. WRC had refused recognition for additional unit of M.Ed. on the ground that it did not have sufficient built up area. The institution has stated that it is having 5674 sq.mts. of built up area and VT was constituted to verify this increase in built up area. The institution has asked for delay of six months on the ground that the building is under construction. The claim of the institution that it is having sufficient built up area could not be verified. As soon as fee for Rs.1.50 lakhs is received, VT be constituted.*" Accordingly, letter dated 03.04.2017 was issued to the institution/Society for submission of the fee as decided by WRC.

And whereas, the matter was taken up by WRC in its 272nd meeting held on April 6-8, 2017 and decided at point **272.1 Confirmation of the minutes of 271st Meeting of WRC**. The minutes of the 271st were confirmed by the Committee except for the following corrections:-

(i) Serial No. 30 (APP1925) :- The decision stands deleted.

And whereas, the WRC also at Sl. No. 36 has decided that "...*Show Cause Notice was issued to the B.A.B.Ed., B.Sc.B.Ed. and M.Ed. additional courses.*"

Since, the institution has not offered any acceptable reply; Recognition is refused as there is no provision in the Regulations for keeping applications pending."

Now, therefore, the WRC, in exercise of the powers vested u/s **15(3) (b) of the NCTE Act, 1993** hereby refuses recognition of **MAHARAJA COLLEGE, PLOT NUMBER: 22, 26/1, STREET NUMBER: 36, VILLEGE: CHANDESRI, POST OFFICE: MOTILAL NEHRU NAGAR, TEHSIL/TALUKA: CHANDESRI, TOWN/CITY: UJJAIN, DISTRICT: UJJAIN 456010, MADHYA PRADESH** for additional intake of the existing M.Ed. Course.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi – 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online, using website www.ncte-india.org.


