Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Chhattisgarh Yuva Vikash Sangthan, Plot No. 104, Street – Behind Pt. R.S.S.U., Raipur, Chhattisgarh – 492010 had submitted the application on 19.12.2012 to the Western Regional Committee of the NCTE for grant of recognition to Vipra Arts Commerce and Physical Education College, Khasra No. – 422/1, 422/7, 422/24, 422/27, Plot No. – 104, Street – Behind Pt. R.S.S.U., Dumar Talab, Raipur, Chhattisgarh-492010 for conducting D.El.Ed. course.

And whereas, the proposal was examined by WRC in its 198th meeting held on 13-13 August, 2013 and Committee decided to issue rejection order on following points:-

"The case file was seen. The institution has applied for new course-D.El.Ed. However, the file shows B.Ed. (100 seats) was recognized on 22.06.2011 for this institution. Since, three academic sessions has not been completed. This application cannot be considered.

The application cannot be considered for Recognition, hence it is rejected."

Accordingly rejection letter was issued to the institution on dt. 29.08.2013. Institution had filed the appeal U/s 18 of the NCTE Act, 1993 before the appellate authority on dt. 30.09.2013.

And whereas, the appellate authority NCTE, New Delhi has been issued the appeal order on dt. 11.12.2013 and matter was remanded back to WRC with a direction to further process the application as per Regulations.

And whereas, the matter was placed before the WRC in its 200th meeting held on 5th-7th February, 2014 and Committee decided to follows:-

"The case file was seen. The WRC had rejected the application for D.El.Ed. course on the ground that three academic sessions had not been completed after grant of B.Ed. course, vide order dated 26.06.2011. The applicant approached the Appellate Authority which has accepted the appeal and remanded the case to WRC. The WRO is directed to process the case as per the appeal order."

Accordingly letter was issued to the institution on dt. 18.02.2014 and reply was submitted by the institution on dt. 06.03.2014.

And whereas, the matter was placed before the WRC in its 210th meeting held on 30th September, 2014 and Committee decided to issue letter of Conveying Decision to the institution on the following points:-

"The case file was seen. It is not possible for WRC to process the application as per the current Regulations as directed by the Appeal Committee since there is a stay on all processing for Recognition by Hon'ble Supreme Court vide its order dated 10.09.2013, 07.03.2014 & 24.03.2014.

The case be considered only after the notification of the new Regulations.

This matter be brought to the notice of NCTE hqrs."

Accordingly letter of conveying decision was issued to the institution on dt. 13.10.2014 & letter of acceptance of NCTE Regulations, 2014 was issued to the institution on dt. 23.12.2014 and reply

was submitted by the institution on dt. 23.01.2015 and also submitted the affidavit regarding acceptance of NCTE Regulations, 2014 on dt. 23.01.2015.

And whereas, the proposal was examined by WRC in its 231st meeting held on 25th-26th August, 2015 and the Show Cause Notice was issued to the institution on 07.09.2015, and reply was submitted by the institution on 15.10.2015 & 08.08.2016.

And whereas, the reply of SCN was placed in 271st meeting held on 23rd - 25th March, 2017 and the Committee decided to constitute visiting team.

And whereas, the inspection of institute was conducted on 24.04.2017.

And whereas, the visiting team report along with other documents, was placed before the WRC in its 274th meeting of WRC held on 27th April, 2017 and Committee decided to issue refusal order to the institution on the following points:-

"The case file was seen. Show Cause Notice was issued to the institution on the ground that it does not have diverted land as required by the Regulations. The institution was asked to submit a valid CLU to the VT members or to the office.

In response, the institution has submitted a premium receipt issued in 2012 for only 15000 sq. ft.

Hence, Recognition is refused."

Now, therefore, in exercise of the powers vested under section 15 (3)(b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to D.El.Ed. course to Vipra Arts Commerce and Physical Education College, Khasra No. - 422/1, 422/7, 422/24, 422/27, Plot No. - 104, Street - Behind Pt. R.S.S.U., Raipur, Chhattisgarh-492010.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order. The guidelines of appeal may be downloaded from the NCTE website.
