**REFUSAL ORDER**

WHEREAS in terms of section 14 of the NCTE Act, 1993, **MARUTI SCHOOL CHIRAHULA REWA, SURVEY NO. 144/2, VILLAGE: MAJHIGAWA (ITAURA), STREET/ROAD: REWA TO SIRMOR ROAD, TALUKA/MANDAL: HUZUR(REWA), TOWN/CITY: REWA, DISTRICT: REWA-486440, MADHYA PRADESH** had submitted the application on **27.04.2016** to the Western Regional Committee of the NCTE for grant of recognition to **MARUTI INSTITUTE OF HIGHER EDUCATION, SURVEY NO. 144/2, VILLAGE: MAJHIGAWA (ITAURA), STREET/ROAD: REWA TO SIRMOR ROAD, TALUKA/MANDAL: HUZUR (REWA), TOWN/CITY: MAJHIGAWA (ITAURA), DISTRICT: REWA-486440, MADHYA PRADESH** for conducting the **B.A.B.Ed./B.Sc.B.Ed. 4 Years integrated programme.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 31.05.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 266<sup>th</sup> meeting held on January 10-12, 2017 and the Committee decided that "...A perusal of the documents shows that the institution has not submitted the certified copy of the land documents. Secondly, final CLU has not been submitted. Thirdly, no other course is being run in the institution making it a standalone institution which is not permitted under clause 2(b) and 3(a) of the NCTE Regulations, 2014. **Hence, Show Cause Notice be issued to the institution on the above grounds as to why the recognition should not be refused. Reply should be submitted within 30 days.**"

AND WHEREAS, the Show Cause Notice was issued on 13.01.2017 through online.

AND WHEREAS, the reply dt. 23.01.2017 of the Institution was placed before WRC in its 270<sup>th</sup> meeting held on March 01-03, 2017. The Committee decided that "...Show Cause Notice was issued to the institution on 13/01/2017. The institution vide reply dt. 23/01/2017 has submitted land documents, CLU. However, the case cannot be considered further till the Appellate Authority gives its order regarding the B.Ed. application APP2875 which was refused earlier."

AND WHEREAS, the Information letter was issued on 10.03.2017 through online/ E-mail.

AND WHEREAS, the matter was placed before WRC in its 279<sup>th</sup> meeting held on August 10-11, 2017. The Committee decided that "...In the 270th meeting, the WRC decided to await the order of the appellate authority. Vide order dated 29.05.2017 it has confirmed the order of the WRC. Hence the Refusal order of the WRC dated 16.07.2016 stands. Since the recognition for B.Ed course is refused, the institute becomes stand alone. Therefore, the application of the institute for B.A-B.Ed/B.Sc-B.Ed cannot be considered. **Hence, recognition is refused. FDRs, if any, be returned.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition to **MARUTI INSTITUTE OF HIGHER EDUCATION, SURVEY NO. 144/2, VILLAGE: MAJHIGAWA (ITAURA), STREET/ROAD: REWA TO SIRMOR ROAD, TALUKA/MANDAL: HUZUR(REWA), TOWN/CITY: MAJHIGAWA (ITAURA), DISTRICT: REWA-486440, MADHYA PRADESH** for the **B.A.B.Ed./B.Sc.B.Ed. 4 - Years integrated programme.**

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website [www.ncte-india.org](http://www.ncte-india.org).
