REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, **Bhagwati Shiksha Samiti**, Village: **Sihoda**, Street/Road: **Near Bheraghat Railway Station**, Taluka/ Mandal+ Town/City : **Jabalpur**, District: **Jabalpur-482002**, **Madhya Pradesh (WRCAPP201660037)** had submitted the application on **17.05.2016** to the Western Regional Committee of the NCTE for grant of recognition/permission to **Shree Venkateshwar B.Ed. College**, Khasra No.: **256/1, 256/2**, **Sihoda**, Street/Road: **Near Bheraghat Railway Station**, Taluka/Mandal: **Jabalpur**, Town / City: **Sihoda**, District: **Jabalpur-482002**, **Madhya Pradesh** for **B.A.B.Ed. 4 years integrated course**.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 12.08.2016 requesting to give their recommendation/ comments.

AND WHEREAS, the matter was considered by WRC in its 264th meeting held on December 14-15, 2016 and decided that: - "The WRO has scrutinized 69 files of the new applications for the academic session 2017-2018. Where the applications are complete for VT, the WRO should send the VT immediately."

AND WHEREAS, the Visiting Team visited the institution on 27.01.2017.

AND WHEREAS, the visiting team report alongwith other document, were placed before WRC in 269th meeting held from February 20-22, 2017 the committee observed that:-

"....The VT visited the institution on 27/01/2017. The VTR was perused and the CD viewed. The CD shows a building which only has a ground floor with inadequate instructional and infrastructural facilities. The multipurpose hall appears small. The ET Lab and the Science Lab are not adequately equipped.

After viewing the CD, the WRC is of the opinion that the college does not give the impression that it can run both the courses successfully. Further, there was no evidence that the college is running B.Ed. program since 2008.

Hence, Show Cause Notice be issued on the above grounds. Reply should be submitted within 30 days."

AND, WHEREAS, the Show Cause Notice was issued on 16.03.2017 on the above grounds.

AND WHEREAS, the reply dt. **15.03.2017** of the Institution was placed before WRC in its **273rd meeting held on April 18-19, 2017**. The Committee decided that "....Show Cause Notice was issued on 16/03/2017 and the institution in its reply has stated that the area of the multipurpose hall is 2156 sq. ft. However, a certificate from the Govt. engineer has not been attached.

Hence, Clarification be obtained on the above grounds.

The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 02.05.2017, can the case be considered for the session 2017-2018."

AND, WHEREAS, the Clarification letter was issued on **22.04.2017** on the above grounds.

AND WHEREAS, the reply dt. **25.04.2017** of the Institution was placed before WRC in its **274th meeting held on April 27, 2017**. The Committee decided that "...Show Cause Notice was issued to the institution on various grounds.

The institution has clarified on the points raised in the Show Cause Notice.

Since the institution has not complied with the directions of the WRC, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition of **Shree Venkateshwar B.Ed. College, Khasra No.: 256/1, 256/2, Sihoda, Street/Road: Near Bheraghat Railway Station, Taluka/Mandal: Jabalpur, Town / City: Sihoda, District: Jabalpur-482002, Madhya Pradesh** for the **B.A.B.Ed. 4 -Years** intregated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
