REFUSAL ORDER

WHEREAS in terms of section 14 of the NCTE Act, 1993, EILM MINORITY SOCIETY, VILLAGE: 101 VIJAYANT TRAVELS, STREET/ROAD: ROXY POOL, TALUKA/MANDAL: KAMPOO LASHKAR, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-474001, MADHYA PRADESH had submitted the application on 30.05.2016 to the Western Regional Committee of the NCTE for grant of recognition to SAI COLLEGE OF EDUCATION, KHASRA NO. 56/1, 61, VILLAGE: PANIHAR NEAR CRP CENTER, STREET/ROAD: SHIVPURI LINK ROAD, TALUKA/MANDAL: GWALIOR, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-475330, MADHYA PRADESH for conducting the D.P.S.E. 2 Years programme.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government were issued on 30.06.2016, 15.08.2016 & 14.09.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 267th meeting held on January 23-25, 2017 and the Committee decided that "....An examination of the documents shows that the institution is a standalone institution which is not permitted as per clause 2(b) of the NCTE Regulations, 2014. The latest CLU with premium receipt has not been submitted. Building Plan, Building Completion Certificate and Non-Encumbrance Certificate have also not been submitted. Hence, Show Cause Notice be issued to the institution on the above ground. Reply should be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued on 06.02.2017 through online.

AND WHEREAS, the reply dt. 18.05.2017 of the Institution was placed before WRC in its 279th meeting held on August 10-11, 2017. The Committee decided that "....Show Cause Notice was issued on 06.02.2017 regarding the fact that the institute is stand alone as its D.El.Ed. course was refused recognition. The institute has not given any satisfactory reply. **Hence, Recognition is refused.** FDRs, if any, be returned."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses recognition to SAI COLLEGE OF EDUCATION, KHASRA NO. 56/1, 61, VILLAGE: PANIHAR NEAR CRP CENTER, STREET/ROAD: SHIVPURI LINK ROAD, TALUKA/MANDAL: GWALIOR, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-475330, MADHYA PRADESH for the D.P.S.E. 2 - Years programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi – 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
