**REFUSAL ORDER**

Whereas in terms of section 15 of the NCTE Act, 1993, **AISECT UNIVERSITY, SURVEY NO. 192/5, VILLAGE: MENDUA, TALUKA/MANDAL: BHOJPUR, TOWN/CITY: RAISEN, DISTRICT: RAISEN-464993, MADHYA PRADESH** had submitted the application on **30.05.2016** to the Western Regional Committee of the NCTE for grant of recognition/permission to **AISECT UNIVERSITY INSTITUTE OF EDUCATION, SURVEY NO. 192/5, 197/4, VILLAGE: MENDUA, STREET/ROAD: CHIKLOD ROAD, TALUKA/MANDAL: GOHARGANJ, TOWN/CITY: MENDUA, DISTRICT: RAISEN-464993, MADHYA PRADESH** for conducting the **B.Ed.M.Ed. 3 Years integrated** programme.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 17.06.2016 requesting to give their recommendation/comments.

AND WHEREAS, in its 266<sup>th</sup> meeting of the WRC held on January 10-12, 2017 it was decided that "*The WRO should process all the files and send VT to all institutions which fulfill all the requirements as per Regulations. Show Cause Notice can be issued to all institution which have not submitted a valid up to date CLU with payment receipts. The rest of the applications should be put up to the WRC for disposal.*"

AND WHEREAS, the Show Cause Notice was issued on 23.01.2017 through online. Reply not submitted by institution.

AND WHEREAS, the matter of reply not received was placed before WRC in its 278<sup>th</sup> meeting held on July 25-26, 2017. The Committee decided that "*....The institute was informed through a show cause notice on 23.01.2017 to submit latest receipt of payment for CLU. The institute has not replied till date. Hence, Recognition is refused. FDRs, if any, be returned.*"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses recognition/permission to **AISECT UNIVERSITY INSTITUTE OF EDUCATION, SURVEY NO. 192/5, 197/4, VILLAGE: MENDUA, STREET/ROAD: CHIKLOD ROAD, TALUKA/MANDAL: GOHARGANJ, TOWN/CITY: MENDUA, DISTRICT: RAISEN- 464993, MADHYA PRADESH** for the **B.Ed.M.Ed. 3 - Years** integrated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website [www.ncte-india.org](http://www.ncte-india.org).
