REFUSAL ORDER

WHEREAS in terms of section 15 of the NCTE Act, 1993, **RAHUL SANKRITYAYAN SHIKSHA AVAM ANUSANDHAN CHARITABLE SAMITI, VILLAGE: GOSWAMI SHASTRI BHAVAN, STREET/ROAD: BEHIND A.G.OFFICE, TALUKA/MANDAL: MAHALGAON, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-474011, MADHYA PRADESH** had submitted the application on **31.05.2016** to the Western Regional Committee of the NCTE for grant of permission to **INSTITUTE OF PROFESSIONAL & TECHNICAL EDUCATION, SURVEY NO. 230, VILLAGE: PIPROLI CHIRWAI NAKA, STREET/ROAD: PIPROLI, TALUKA/MANDAL: GWALIOR, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-474001, MADHYA PRADESH** for conducting the **M.Ed. 2 Years** programme.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 20.06.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 268th meeting held on February 9-11, 2017 and the Committee decided that "...A perusal of the documents shows that the institution has not submitted a valid CLU with latest premium receipt. Since, the Recognition for the B.Ed. course was granted on 19/04/2016. Hence, the institution is not eligible to apply for the M.Ed. course. As per NCTE Regulations, 2014, the B.Ed. should have been running for at least 5 years. The institution should submit the latest position regarding NAAC application. **Hence, Show Cause Notice be issued as to why the recognition should not be refused on the above grounds. Reply should be submitted within 30 days.**"

AND WHEREAS, the Show Cause Notice was issued on 16.02.2017 through online.

AND WHEREAS, the reply dt. 10.03.2017 of the Institution was placed before WRC in its 279th meeting held on August 10-11, 2017. The Committee decided that "...The Show Cause Notice was issued on the ground that the institute is not running a teacher education programme for a minimum period of 5 academic years affiliated to a university. It should have also applied for an accreditation from NAAC. The institute has not given any valid reply. **Hence recognition is refused. FDRs, if any, be returned.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses permission to **INSTITUTE OF PROFESSIONAL & TECHNICAL EDUCATION, SURVEY NO. 230, VILLAGE: PIPROLI CHIRWAI NAKA, STREET/ROAD: PIPROLI, TALUKA/MANDAL: GWALIOR, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-474001, MADHYA PRADESH** for the **M.Ed. 2 - Years** programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
