REFUSAL ORDER

WHEREAS in terms of section 14 of the NCTE Act, 1993, **SHRI HARNAM SINGH SHIKSHA SAMITI, VILLAGE: KAMTONE, STREET/ROAD: J.J.ROAD BARELI, TALUKA/MANDAL: BHOOPAL, TOWN/CITY: BARELI, DISTRICT: RAISEN-464668, MADHYA PRADESH** had submitted the application on **31.05.2016** to the Western Regional Committee of the NCTE for grant of recognition to **CHOUDHARY INSTITUTE OF PROFESSIONAL EDUCATION, VILLAGE: KAMTONE, STREET/ROAD: J.J. ROAD NH-12, TALUKA/MANDAL: BARELI, TOWN/CITY: KAMTONE, DISTRICT: RAISEN-464668, MADHYA PRADESH** for conducting the **B.A.B.Ed./B.Sc.B.Ed. 4 Years integrated programme.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 17.06.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 267th meeting held on January 23-25, 2017 and the Committee decided that "....An examination of the documents shows the following deficiencies:-

- The institution is a standalone institution which is not permitted as per clause 2(b) of the NCTE Regulations, 2014.
- The institution should clarify which course it wants to run B.A.B.Ed. or B.Sc.B.Ed. course.
- The latest premium receipt for the CLU has not been submitted.
- Building Completion Certificate has not been submitted.

Hence, Show Cause Notice be issued to the institution on the above ground. Reply should be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued on 01.02.2017 through online.

AND WHEREAS, the matter of reply not received was placed before WRC in its 279th meeting held on August 10-11, 2017. The Committee decided that "....Show Cause Notice/ Clarification letter was issued on 01.02.2017. Till date no reply has been received. **Hence, Recognition is refused. FDRs, if any, be returned."**

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses recognition to **CHOUDHARY INSTITUTE OF PROFESSIONAL EDUCATION, VILLAGE: KAMTONE, STREET/ROAD: J.J. ROAD NH-12, TALUKA/MANDAL: BARELI, TOWN/CITY: KAMTONE, DISTRICT: RAISEN-464668, MADHYA PRADESH** for the **B.A.B.Ed./B.Sc.B.Ed. 4-Years integrated programme.**

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
