REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, KAUSHILYA RANI SHIKSHA SAMITI, VILLAGE: RAUSAR, STREET/ROAD: RAUSAR, TALUKA/MANDAL: HUZUR, TOWN/CITY: REWA, DISTRICT: REWA 486006, MADHYA PRADESH (WRCAPP201660116/B.A.B.Ed.) had submitted the application on 31.05.2016 to the Western Regional Committee of the NCTE for grant of recognition/permission to RANI COLLEGE OF EDUCATION, VILLAGE: RAUSAR, STREET/ROAD: TIGER SAFFARI ROAD, TALUKA/MANDAL: HUZUR, TOWN/CITY: RAUSAR, DISTRICT: REWA 486006, MADHYA PRADESH for B.A.B.Ed. 4 years integrated course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 20.06.2016, 12.08.2016 & 01.09.2016 requesting to give their recommendation/comments.

AND WHEREAS, in 264th meeting of the WRC held on December 14-15, 2016 it was decided as under:

"The WRO has scrutinized 69 files of the new applications for the academic session 2017-2018. Where the applications are complete for VT, the WRO should send the VT immediately."

AND WHEREAS, VT was constituted. The Visiting Team visited the institution on 02.02.2017.

AND WHEREAS, the visiting team report alongwith other document, were placed before WRC in 270^{th} meeting held on March 1-3, 2017 the committee observed that:-

"...The VT visited the institution on 02/02/2017. The CD was seen and VTR perused. The CD shows a good building with adequate instructional and infrastructural facilities. The VT has recommended the case. Hence, LOI be issued for 1 unit of the B.A.B.Ed. course."

AND WHEREAS, the Letter of intent was issued on 10.03.2017.

AND WHEREAS, the reply dt. 02.05.2017 of the Institution was placed before WRC in its 275th meeting held on May 1-2, 2017. The Committee decided that "....Consequent to the issue of LOI, the institution has submitted a list of 6 faculty members who are qualified but not approved by the competent authority. Staff has not been appointed as per requirement specified in Appendix-13 of the NCTE Regulations, 2014. Hence, Show Cause Notice be issued on the above grounds."

AND WHEREAS, the Show Cause Notice was issued on 19.05.2017.

AND WHEREAS, the reply dt. 12.05.2017 of the Institution was placed before WRC in its 279th meeting held on August 10-12, 2017. The Committee decided that "... Show Cause Notice was issued to the institution on 19.05.2017 regarding approval of staff profile as well as nonappointment of required staff as per appendix 13 of the NCTE Regulations, 2014. The institute has not fulfilled this requirement. Hence, Recognition is refused. FDRs, if any, be returned."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition/permission to Rani College of Education, Village: Rausar, Street/Road : Tiger Saffari Road, Taluka/Mandal : Huzur, Town/City: Rausar, District: Rewa 486006, Madhya Pradesh for the B.A.B.Ed. 4 - Years integrated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
