REFUSAL ORDER

WHEREAS in terms of section 15 of the NCTE Act, 1993, **SHRI RAMNATH SINGH SHIKSHA PRASAR SAMITI, VILLAGE: GORMI, STREET/ROAD: GORMI ROAD, TALUKA/MANDAL: MEHGAON, TOWN/CITY: GORMI, DISTRICT: BHIND-477660, MADHYA PRADESH** had submitted the application on **31.05.2016** to the Western Regional Committee of the NCTE for grant of recognition/permission to **SHRI RNS SHIKSHA MAHAVIDYALAYA, VILLAGE: GWALIOR, STREET/ROAD: RNS CAMPUS, OPPOSITE SITHOLI RAILWAY STATION, TALUKA/MANDAL: GWALIOR, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR- 474001, STATE: MADHYA PRADESH** for conducting the **B.A.B.Ed./B.Sc.B.Ed. 4 Years integrated programme.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 01.09.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 267th meeting held on January 23-25, 2017 and the Committee decided that "...An examination of the documents shows the following deficiencies:-

- The institution should clarify which course it wants to run B.A.B.Ed. or B.Sc.B.Ed. course.
- The CLU is only for 2043 sq. mtrs. which is insufficient. The latest premium receipt for the CLU has not been submitted.
- In the Building Plan the built up area is shown as 1683 sq.mtrs. which is grossly less than the requirement.
- Building Completion Certificate from the competent authority and Non-Encumbrance Certificate not been submitted.

Hence, Show Cause Notice be issued to the institution on the above ground. Reply should be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued on 06.02.2017 through online.

AND WHEREAS, the matter of reply not received was placed before WRC in its 279th meeting held on August 10-11, 2017. The Committee decided that "...Show Cause Notice/ Clarification letter was issued on 06.02.2017. Till date no reply has been received. **Hence, Recognition is refused. FDRs, if any, be returned."**

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition/permission to **SHRI RNS SHIKSHA MAHAVIDYALAYA, VILLAGE: GWALIOR, STREET/ROAD: RNS CAMPUS, OPPOSITE SITHOLI RAILWAY STATION, TALUKA/MANDAL: GWALIOR, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-474001, STATE: MADHYA PRADESH** for the **B.A.B.Ed./ B.Sc.B.Ed. 4 - Years integrated programme.**

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
