REFUSAL ORDER

WHEREAS in terms of section 15 of the NCTE Act, 1993, **SHIV NARAYAN FOUNDATION, VILLAGE: KARMETA, STREET/ROAD: PATAN ROAD, TALUKA/MANDAL: NEAR MPRTC DEPOT, TOWN/CITY: JABALPUR, DISTRICT: JABALPUR-482002, MADHYA PRADESH** had submitted the application on **31.05.2016** to the Western Regional Committee of the NCTE for grants of permission to **JABALPUR PUBLIC COLLEGE, VILLAGE: KARMETA, STREET/ROAD: PATAN ROAD, TALUKA/MANDAL: NEAR MPRTC DEPOT, TOWN/CITY: JABALPUR, DISTRICT: JABALPUR-482002, MADHYA PRADESH** for conducting the **B.Ed.M.Ed. 3 Years integrated** programme.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 30.06.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 267th meeting held on January 23-25, 2017 and the Committee decided that "....Although the institution fulfils the conditions necessary for their application of B.Ed.M.Ed. course, the case cannot be processed because the institution has not submitted the reply to the Show Cause Notice dt. 02/08/2016 for the B.Ed. course and 06/01/2017 for the M.Ed. course. **The case will be considered further as soon as satisfactory replies are received for the Show Cause Notices.** Further, for the B.Ed.M.Ed. course, as per clause 2(iii) of Appendix-15, hostel facilities are required."

The following deficiencies /shortcomings were also added in the Show Cause Notice:-

1. Institution has applied at Khasra No. 445/48 & 446/48, whereas, the Land document, Building Plan and Non-Encumbrance certificate submitted of Khasra No. 445/2, 446/2, 447/2 & 448/2. Land document, Building Plan and Non-Encumbrance certificate of Khasra No. 445/48 & 446/48, not submitted by institution.
2. All Existing courses are running by institution at Khasra No. 445/2, 446/2 only.
3. As per land document of Khasra No. 445/2, 446/2, 447/2 & 448/2 Submitted by institution, Total land area is 0.337 Hect. Only, which is much less than required as per NCTE norms.
4. As per Building Completion certificate, Total Built-up area is 55019 sq.ft. (5111.43 Sq.mtr) which is less than required as per NCTE norms.
5. Building Completion certificate, Change of Land Use certificate/Diversion order of 445/2, 446/2, 447/2 & 448/2 are not submitted by institution.
6. The institution has not mentioned the details of existing D.Ed course for 100 seats, D.Ed (Addl) for 50 seats & B.A.B.Ed course for 50 seats in online application at the details of existing Teacher Education programs.
7. As per diversion order dt. 5.2.2011 of Khasra No. 445/48, 446/48, 447/48, 448/48, Total diverted land area is 20000 Sq.ft. (1858.06 Sq.mtr.) only. This is much less than the requirement as per NCTE, norms.

AND WHEREAS, the Show Cause Notice was issued on 14.02.2017 through online.

AND WHEREAS, the matter of reply not received was placed before WRC in its 279th meeting held on August 10-11, 2017. The Committee decided that "...Show Cause Notice/ Clarification letter was issued on 14.02.2017. Till date no reply has been received. **Hence, Recognition is refused. FDRs, if any, be returned.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses permission to **JABALPUR PUBLIC COLLEGE, VILLAGE: KARMETA, STREET/ROAD: PATAN ROAD, TALUKA/MANDAL: NEAR MPRTC DEPOT, TOWN/CITY: JABALPUR, DISTRICT: JABALPUR-482002, MADHYA PRADESH** for the **B.Ed.M.Ed. 3 - Years** integrated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
