REFUSAL ORDER

WHEREAS, in terms of Section 14 (1) of the NCTE Act, 1993, **OM SHIKSHA EVAM SAMAJ KALYAN SAMITI, KHASRA NO.: 21/124, STREET/ROAD: MATHUR COLONY, TALUKA/MANDAL+ TOWN/CITY: GUNA, DISTRICT: GUNA-473001, MADHYA PRADESH** (WRCAPP201660179/ID.7500) had submitted the application on **21.06.2016** to the Western Regional Committee of the NCTE for grant of recognition/permission to **GANDHI VOCATIONAL B.ED. COLLEGE, KHASRA NO. 244, 245, VILLAGE: KUSHMODA, STREET/ROAD: A.B.ROAD, TALUKA/MANDAL+ TOWN/CITY: GUNA, DISTRICT: GUNA-473001, MADHYA PRADESH** for **B.Ed.M.Ed. 3 years integrated course.**

AND WHEREAS, the matter was placed before the WRC in its **268th meeting held on February 09-11, 2017** and the Committee decided that *"....The institution is running the B.Ed. course with 2 units from 2006. It has now applied for 2 courses – M.Ed. for 1 unit and the B.Ed.M.Ed. integrated course for 1 unit. The institution is not eligible to apply for the B.Ed.M.Ed. course as it has not run the M.Ed course at least for 5 years.*

The application of the institution for the M.Ed. course is being processed. The institution has not submitted the latest premium receipt for the CLU. The institution should also form the latest position about the NAAC accreditation.

Hence, Show Cause Notice be issued as to why the recognition should not be refused on the above grounds. Reply should be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued on 16.02.2017 through online mode.

AND WHEREAS, the reply of Show Cause Notice from the Institution received and placed before WRC in its **271st meeting held on March 23-25, 2017.** The Committee decided that *"....Show Cause Notice was issued to the institution on 16.02.2017 and reply received on 06.02.2017 and 21.02.2017. The institution has not given any reply regarding its ineligibility to apply for the B.Ed. M.Ed. (Integrated) course.*

Hence, Recognition is refused u/s 14(3)(b) of NCTE Act, 1993.

Regarding the M.Ed. programme the institution has now submitted the latest premium receipt of CLU/diversion. The institution was asked to provide the latest position regarding NAAC ACCREDITATION. The last letter produced by the institution is dated 28.07.2016. The case can be processed further as soon as a reply is submitted by the institution regarding the latest position consequent to the letter referred to above.

Hence, Clarification be obtained from the institution on these grounds."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act; 1993 hereby refuses recognition/permission to **GANDHI VOCATIONAL B.ED. COLLEGE, KHASRA NO. 244, 245, VILLAGE: KUSHMODA, STREET/ROAD: A.B.ROAD, TALUKA/MANDAL+ TOWN/CITY: GUNA, DISTRICT: GUNA-473001, MADHYA PRADESH** for the **B.Ed.M.Ed. 3 -Years integrated programme.**
