REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, TATA INSTITUTE OF SOCIAL SCIENCE, DEONAR - V.N.PURAV MARG,- DEONAR, GR. MUMBAI, MAHARASHTRA (**WRCAPP201660186/B.Ed.M.Ed.**) had submitted the application on **30.05.2016** to the Western Regional Committee of the NCTE for grant of recognition/permission to TATA INSTITUTE OF SOCIAL SCIENCE, VILLAGE-DEONAR, STREET/ROAD - V.N. PURAV MARG, TALUKA/MANDAL - DEONAR, MUMBAI, MUMBAI, MAHARASHTRA for **B.Ed.M.Ed.** 3 years integrated course.

AND WHEREAS, As directed by WRC in 264th meeting held on December 14-15, 2016. The WRO decided that VT be constituted. Accordingly, inspection was conducted on 04.02.2017 to 05.02.2017"

AND, whereas, the matter was placed before WRC in its 269th meeting held on February 20-22, 2017. The Committee decided to issue show cause notice to the institution. Accordingly show cause notice issued on 10.03.2017, and institution submitted reply of show cause notice on 22.03.2017.

AND, whereas, the matter was place before WRC in its 271th meeting held on April 23-25, 2017. The Committee decided to issue letter of intent to the institution. Accordingly, letter of intent was issued on 31-03.2017. The institution submitted reply of letter of intent on 02.05.2017.

AND, whereas, the matter was placed before the WRC in its 275th meeting held on May 01-02, 2017. The Committee decided as follows:-

"Consequent to the issue of LOI, the institution has informed that the recruitment is still under process. **Hence, Show Cause Notice be issued on the above grounds.**"

AND WHEREAS, the Show Cause Notice was issued on 16.05.2017.

AND WHEREAS, the reply dt. 16.06.2017 of the Institution was placed before WRC in its 281st meeting held on September 19th - 20th, 2017. The Committee decided that "...Show Cause Notice was issued to the institution on 16.05.2017 and the institute replied on 16.06.2017. In their reply the institute has said that it has five faculty members and additional faculty will be added after the start of the programme. This is not permitted by NCTE Regulations Appendix-15. **Hence, Recognition is refused.** FDR, if any, be returned."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition/permission to TATA INSTITUTE OF SOCIAL SCIENCE, VILLAGE-DEONAR, STREET/ROAD - V.N. PURAV MARG, TALUKA/MANDAL - DEONAR, MUMBAI, MUMBAI, MAHARASHTRA for the **B.Ed.M.Ed.** 3 - Years integrated programme.
