#### **REFUSAL ORDER**

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, SHRI BHUPENDRA DUTT PANDEY EDUCATION SOCIETY, KHASRA NO. 9, 11, 12, 11/2/1, 11/2/2, STREET/ROAD: GANDHI CHOWK, TALUKA/MANDAL: RAGHURAJ NAGAR, TOWN/CITY: SATNA, DISTRICT: SATNA-485001, MADHYA PRADESH (WRCAPP201660189) had submitted the application on 04.07.2016 to the Western Regional Committee of the NCTE for grant of recognition/permission to CHANDRASHEKHAR SHIKSHA MAHAVIDYALAYA, KHASRA NO. 11/2/1, VILLAGE: BAGHA, STREET/ROAD: KOTHI ROAD, TALUKA/MANDAL: RAGHURAJ NAGAR, TOWN/CITY: SATNA, DISTRICT: SATNA-485001, MADHYA PRADESH for B.A.B.Ed./ B.Sc.B.Ed. 4 years integrated course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 16.08.2016, 16.09.2016 & 16.10.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 265<sup>th</sup> meeting held on December 27-29, 2016 and the Committee decided that "....An examination of the file shows that the institution is having the required land and built up area. Hence, VT be constituted."

AND WHEREAS, the Visiting Team visited the institution on 24.01.2017.

AND WHEREAS, the visiting team report alongwith other documents were placed before WRC in its 270<sup>th</sup> meeting held on March 01-03, 2017. The Committee decided that "...*The VT visited the institution on* 24/01/2017.

The CD was seen and VTR perused and the observation of the VT is "... When VT members reached to inspect the institution on dated 24.1.2017, the building of B.A.B.Ed./B.Sc.B.Ed. could not be seen. As per the management statement the building is under construction and it is not in a position to inspect. The management also stated that it has not submitted the building completion certificate to WRC NCTE for the same.

Hence, Show Cause Notice be issued to the institution as to why the Recognition should not be refused on the above grounds. Reply should be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued on 14.03.2017. Reply submitted by institution on 03.04.2017

AND WHEREAS, the reply submitted by Institution was placed before WRC in its 273<sup>rd</sup> meeting held on April 18-19, 2017. The Committee decided that"...Consequent to the Show Cause Notice issued on 14/03/2017, the institution replied on 03/04/2017.

The institution has not been able to submit a satisfactory reply. Hence, Recognition is refused. FDRs, if any be returned."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses recognition/permission to CHANDRASHEKHAR SHIKSHA MAHAVIDYALAYA, KHASRA NO. 11/2/1, VILLAGE: BAGHA, STREET/ROAD: KOTHI ROAD, TALUKA/MANDAL: RAGHURAJ NAGAR, TOWN/CITY: SATNA, DISTRICT: SATNA-485001, MADHYA PRADESH for the B.A.B.Ed./ B.Sc.B.Ed. 4 - Years integrated programme.
