REFUSAL ORDER

WHEREAS in terms of section 15 of the NCTE Act, 1993, **SHRI RAMA KRISHNA CHARITABLE TRUST, VILLAGE: KARHI KOTHAR, STREET/ROAD: CHANDI DAI MANDIR MODE NEAR SAHARA CITY, TALUKA/MANDAL: RAGHURAJNAGAR, TOWN/ CITY: SATNA, DISTRICT: SATNA-485001, MADHYA PRADESH** had submitted the application on **28.06.2016** to the Western Regional Committee of the NCTE for grant of permission to **SHRI RAMA KRISHNA COLLEGE OF TEACHER EDUCATION, KHASRA NO.84/2, 85/2, 86/2/KHA, 88/2, VILLAGE: KARHI PAWAI, STREET/ROAD: CHANDI DAI MANDIR MODE NEAR SAHARA CITY, TALUKA/MANDAL: RAGHURAJNAGAR, TOWN/CITY: SATNA, DISTRICT: SATNA-485001, MADHYA PRADESH** for conducting the **B.A.B.Ed./B.Sc.B.Ed. 4 Years integrated** programme.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 01.08.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 268th meeting held on February 09-11, 2017 and the Committee decided that "...The institution is running the D.El.Ed. course with 2 units, the B.Sc.B.Ed. with 2 units, B.A.B.Ed. with 2 units and the B.Ed. with 2 units. The institution's attention is drawn to the NCTE Hqrs. letter dated 08.12.2016 which has clarified that, "...the institutions may apply for increase in intake in the same course already recognized provided it does not exceed maximum of two permissible units in case of DPSE, D.El.Ed. and B.Ed. Any application for increase in intake beyond two permissible units in these three courses is not permissible under the regulation..." **Hence, Show Cause Notice be issued as to why the recognition should not be refused on the above grounds. Reply should be submitted within 30 days.**"

AND WHEREAS, the Show Cause Notice was issued on 20.02.2017 through online.

AND WHEREAS, the matter of reply not received was placed before WRC in its 279th meeting held on August 10-11, 2017. The Committee decided that "...Show Cause Notice/Clarification letter was issued on 20.02.2017. Till date no reply has been received. **Hence, Recognition is refused. FDRs, if any, be returned.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses permission to **SHRI RAMA KRISHNA COLLEGE OF TEACHER EDUCATION, KHASRA NO.84/2, 85/2, 86/2/KHA, 88/2, VILLAGE: KARHI PAWAI, STREET/ROAD: CHANDI DAI MANDIR MODE NEAR SAHARA CITY, TALUKA/MANDAL: RAGHURAJNAGAR, TOWN/CITY: SATNA, DISTRICT: SATNA-485001, MADHYA PRADESH** for the **B.A.B.Ed./B.Sc.B.Ed. 4-Years integrated** programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
