**REFUSAL ORDER**

WHEREAS, in terms of **Section 15 (1)** of the NCTE Act, 1993, **GYANODAYA SHIKSHA SAMITI, KHASARA NO.: 25, STREET/ROAD: NAYA BAZAR, TALUKA/MANDAL: NEEMUCH, TOWN/CITY: NEEMUCH, DISTRICT: NEEMUCH - 458441, MADHYA PRADESH (WRCAPP201660222)** had submitted the application on **14.07.2016** to the Western Regional Committee of the NCTE for grant of recognition to **BALKAVI BAIRAGI TEACHER EDUCATION RESEARCH CENTER, VILLAGE: KANAWATI, STREET/ROAD: MHOW-NASIRABAD ROAD, TALUKA/MANDAL: NEEMUCH, TOWN/CITY: KANAWATI, DISTRICT: NEEMUCH-458441, MADHYA PRADESH** for **M.Ed.** course of 4 year duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 05.08.2016, 20.09.2016, 04.11.2016 requesting to give their recommendation/ comments.

AND WHEREAS, Recommendation from Department of Higher Education, Govt. of M.P., Bhopal not received.

AND WHEREAS, the WRC in its **266<sup>th</sup> meeting held on January 10-12, 2017** decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be.

AND, WHEREAS, the Show Cause Notice was issued on **31.01.2017** on the ground that the Latest receipt of payment for CLU not submitted.

AND WHEREAS, the reply dt. **06.02.2017** of the Institution was placed before WRC in its **270<sup>th</sup> meeting held on March 01-03, 2017**. The Committee decided that *"....The institution is running 2 units of the B.Ed. course (223072), 1 unit of the B.Sc.B.Ed. (APP3165), and 2 units of the D.El.Ed course (222035). It had applied for the M.Ed. and B.A.B.Ed. course (APP201660222).*

*The management vide letter dt. 02/02/2017 has requested that application for the M.Ed. should not be considered. Hence, Recognition is refused. FDRs, if any, be returned."*

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses recognition/permission to **BALKAVI BAIRAGI TEACHER EDUCATION RESEARCH CENTER, VILLAGE: KANAWATI, STREET/ROAD: MHOW-NASIRABAD ROAD, TALUKA/MANDAL: NEEMUCH, TOWN/CITY: KANAWATI, DISTRICT: NEEMUCH-458441, MADHYA PRADESH** for the **M.Ed. 2 -Years** programme.
