**REFUSAL ORDER**

WHEREAS in terms of section 15 of the NCTE Act, 1993, **OM SHIV SHANKAR SHIKSHA EVAM SAMAJ KALYAN SAMITI, VILLAGE: KEDARPUR, STREET/ROAD: PIPROLI ROAD, TALUKA/MANDAL: SHIVPURI LINK ROAD, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-474002, MADHYA PRADESH** had submitted the application on **30.06.2016** to the Western Regional Committee of the NCTE for grant of permission to **NATIONAL EDUCATION COLLEGE, PLOT/KHASRA NO.: 226/2, VILLAGE: KEDARPUR, STREET/ROAD: SHIVPURI LINK ROAD, TALUKA/MANDAL: KEDARPUR, PIPROLI ROAD, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-474001, MADHYA PRADESH** for conducting the **B.Ed.M.Ed. 3 Years integrated** programme.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 16.08.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 269<sup>th</sup> meeting held on February 20-22, 2017 and the Committee decided that "...The institution has applied for the B.Ed.M.Ed. course with 1 unit. The attention of the institution is drawn to the Appendix-15 of the NCTE Regulations, 2014 under Section 2 which is mentioned below:-

- NCTE recognized Teacher Education Institutions offering B.Ed. and M.Ed. programmes which have been in existence for at least five years and having NAAC Accreditation with minimum B grade.
- Departments/Schools of Education in UGC recognized Central/State Universities, other than open universities.
- Institutions mentioned at (i) and (ii) above shall have residential accommodation for the conduct of this programme.

A perusal of the file shows that the institution is not running the M.Ed. course. **Hence, Show Cause Notice be issue on the above grounds. Reply should be submitted within 30 days."**

AND WHEREAS, the Show Cause Notice was issued on 01.03.2017 through online.


AND WHEREAS, the reply dt. 20.03.2017 & 01.06.2017 of the Institution were placed before WRC in its 279<sup>th</sup> meeting held on August 10-11, 2017. The Committee decided that "...Show Cause Notice was issued on the ground that the institute is not running the M.Ed. programme and hence not eligible. **Therefore, recognition is refused. FDRs, if any, be returned."**

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses permission to **NATIONAL EDUCATION COLLEGE, PLOT/KHASRA NO.: 226/2, VILLAGE: KEDARPUR, STREET/ROAD: SHIVPURI LINK ROAD, TALUKA/MANDAL: KEDARPUR, PIPROLI ROAD, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR-474001, MADHYA PRADESH** for the **B.Ed.M.Ed. 3-Years** integrated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website [www.ncte-india.org](http://www.ncte-india.org).
