Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Chetana Education Society, Plot No. Deoli Road, Village-Sawangi Meghe, Post Office-Wardha Ganj, Tehsil/City-Wardha, Dist.-Wardha-442001, Maharashtra had submitted the application on 28.12.2012 to the Western Regional Committee of the NCTE for grant of recognition to Subhedar Ramji Ambedkar Sharirik Shikshan Mahavidyalaya, Plot No.29/1B, 29/2, 29/3, Street no.-53, Village-Taharpur, Post Office-Waigaon, Tehsil/City-Wardha, Dist.-Wardha, Maharashtra-442108 for starting the B.P.Ed. Course.

And, whereas, the proposal was examined and the Show Cause Notice under clause 7 (1-A) (i) was issued to the institution on 15.03.2013.

And, whereas, the reply submitted by the institution, was received on 18.04.2013.

And, whereas, the matter was placed before WRC in its 184th meeting held on May 27-29, 2013. The committee decided that ".... Show Cause Notice was issued to the institution for late deposit of processing fee. On the issue of deposit of processing fee, the present rule as contained in the NCTE notification dated 25.11.2010 is as follow "....(a) The processing fee, as provided under rule 9 of the National Council for Teacher Education Rules, 1997 is not furnished on or before the date of submission of online application...", the case cannot be considered.

Hence, the application is summarily rejected.

And, whereas, Rejection order was issued to the institution on 13.06.2013

And, whereas, the institution preferred an appeal before the Council (NCTE) under section 18 of NCTE Act, 1993. The Appellate Authority vide order dated 06.02.2014 accepted the appeal and remanded the matter to the WRC for further consideration as per Regulations.


And, whereas, the matter was placed before WRC in its 223rd meeting held on 23-24, April, 2015, and the Committee decided to issue show cause notice to the institution Accordingly, show cause notice was issued on 30.04.2015, and the institution did not submit reply of show cause notice.

And, whereas, the matter was placed before WRC in its 240th Meeting held on January 20-22, 2016 and the Committee decided to seek clarification from the institution. Accordingly, clarification was sought on 05.02.2016, and institution did not submit reply of Clarification.

And, whereas, the matter was placed before WRC in its 266th meeting held on 10-12, January, 2017, and the Committee decided as follows:-

"...Clarification letter/Show Cause Notice dt. 05.02.2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused.

Now, therefore, in exercise of the powers vested under section 15(3)(b) of NCTE Act, 1993, the Western Regional Committee hereby refuses permission to Subheddar Ramji Ambedkar Sharirik Shikshan Mahavidyalaya, Plot No. -29/1B, 29/2, 29/3, Street No. 53, Village-Taharpur, Post Office-Waigaon, Tehsil/City-Wardha, Dist.-Wardha, Maharashtra-442108 for conducting the B.Ed.Ed. Programme.

Further, if the institution is not satisfied by the order, they may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
