**Refusal Order**

Whereas in terms of section 14 of the NCTE Act, 1993, District Institute of Education And Training, Plot/Khasara No. - 23/1-2, Village/ Post office - Waghai, Tehsil/Taluka - Ahwa, District - The Dangs - 394730, Gujarat, had applied on 31.12.2012 in the Western Regional Committee, NCTE, Bhopal under section 14 of the NCTE Act, 1993, for grant of recognition for conducting B.Ed. Course.

And whereas, file was scrutinized and the document found in order. Keeping in view of the decision taken in 236th WRC meeting, VT constituted.

And whereas, the inspection of institution was conducted on 11.02.2016.

And whereas, WRC considered visiting team report along with regulatory file and other relevant document placed in 243th meeting held on 18th - 20th February, 2016 and committee decided to issue LOI. Accordingly, LOI was issued to the institution on 24.02.2016, and reply was submitted by the institution on dt. 26.02.2016

And whereas, the reply of LOI was placed in 245th meeting held on 01th -03rd March, 2016 and Committee decided to issue Show Cause Notice. Accordingly Show Cause Notice was issued to the institution on 11.03.2016, and reply was submitted by the institution on dt. 21.04.2016.

And whereas, the reply of Show Cause Notice was placed in 249th meeting held on April 30th-May 02nd 2016 and committee decided to issue Show Cause Notice. Accordingly Show Cause Notice was issued to the institution on 05.05.2016, and reply is not submitted by the institution within 30 days as per SCN.

And whereas, the case was placed in 266th meeting held on 10th-12th January, 2017 and committee was decided to issue refusal order to the institution on the following points:-

"The case file was seen. Clarification letter/Show Cause Notice dt. 05/05/2016 was issued to the institution. Reply has not been received till date.

**Hence, Recognition is refused."**

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuses grant of recognition to the District Institute of Education And Training, Plot/Khasara No. - 23/1-2, Village/ Post office - Waghai, Tehsil/Taluka - Ahwa, District - The Dangs - 394730, Gujarat.

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 [www.ncte-india.org](http://www.ncte-india.org) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
