Whereas in terms of section 15 of the NCTE Act, 1993, District Institute of Education and Training, Plot No. 1301, Street No. - Ganeshpura, Village/Post office - Palanpur, Tehsil/Taluka - Palanpur, District - Banaskantha, Gujarat - 385001, had submitted the application on 26.07.2013 to the Western Regional Committee of the NCTE for grant of recognition to District Institute of Education and Training, Plot No. 1301, Street No. - Ganeshpura, Village/Post office - Palanpur, Tehsil/Taluka - Palanpur, District - Banaskantha, Gujarat - 385001.

And whereas, file was scrutinized and the document found in order. Keeping in view of the decision taken in 236th WRC meeting, VT constituted.

And whereas, the inspection of institution was conducted on 08.02.2016.

And whereas, WRC considered visiting team report alongwith regulatory file and other relevant document placed in 242th meeting held on 11th - 13th February, 2016 and committee decided to issue Show Cause Notice. Accordingly, Show Cause Notice was issued to the institution on 17.02.2016, and reply was submitted by the institution on dt. 28.12.2016

And whereas, the reply of SCN was placed in 265th meeting held on 27th -29th December, 2016 and Committee decided to issue refusal order to the institution on the following points:-

"The case file was seen. Show Cause Notice was issued to the institution on the ground that built up area is only 1165.89 sq. mtrs. The institution has not submitted any document regarding adequate built up area.

Hence, Recognition is refused."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to, District Institute of Education and Training, Plot No. 1301, Street No. - Ganeshpura, Village/Post office - Palanpur, Tehsil/Taluka - Palanpur, District - Banaskantha, Gujarat - 385001**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
