**Refusal Order**

Whereas in terms of Section 15 of the NCTE Act, 1993, Shri Kamdar Education Trust, Plot Number – 7<sup>th</sup> Floor, Street/Road – Neptune Tower, Village – Kalwad Road Rajkot, Post office/Tehsil/Taluka – Rajkot, District – Rajkot – 360007 had submitted the application on 07.04.2015 to the Western Regional Committee of the NCTE for grant of recognition to Shri And Smt. V K Kamdar B.Ed. College, Plot/Khasara Number – Haripar Pal Survey Number 12, Plot Number – Survey Number 12, Street Number – Kalawad Road, Village – Haripar Pal, Post office/Tehsil/Taluka – Rajkot, District – Rajkot (GJ), Gujarat - 360007. for B.Ed. (increase intake) 02 years course for the academic session 2016-2017.

And whereas, the proposal was examined and the Show Cause Notice was issued to the institution on 09.02.2016, and reply was submitted by the institution, was received on 10.03.2016.

And whereas, the reply of SCN was placed in 247<sup>th</sup> meeting held on 04 - 06<sup>th</sup> April, 2016 and the Committee decided to issue refuse recognition to the institution on the following points:-

"The institution is running the B.Ed. course with two units and has applied for the increase in intake. The institution is not a composite institution. Any new application has to be in a composite institution.

Show Cause Notice was issued on 09/02/2016 on seven grounds. The institution has replied on 05/03/2016. It is seen that the institution has not still submitted the NOC from the affiliating body. It has also not submitted notarized copy of CLU, building plan, Building Completion Certificate and Non-Encumbrance Certificate.

**Hence, Recognition is refused. FDRs if any, be returned."**

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of the NCTE Act, 1993, **the Western Regional Committee hereby refuses recognition to Shri And Smt. V K Kamdar B.Ed. College, Plot/Khasara Number – Haripar Pal Survey Number 12, Plot Number – Survey Number 12, Street Number – Kalawad Road, Village – Haripar Pal, Post office/Tehsil/Taluka – Rajkot, District – Rajkot (GJ), Gujarat – 360007 for B.Ed. (increase intake) 02 years course.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 [www.ncte-india.org](http://www.ncte-india.org) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
